ORDER

In the G.O. first read above, the Government have permitted for the construction of 22000 houses in both rural and urban areas under Rajiv Gandhi Rehabilitation Package and have sanctioned a sum of Rs.552/- crores for this purpose, which includes cost of construction of houses, basic amenities and insurance.

- 2. The Special Commissioner and Commissioner of Revenue Administration in his letter second read above has stated that the Project Director, Tsunami Project Implementation Unit, Rural Development and Panchayat Raj Department has requested to sanction funds for payment of rent at Rs.500/- per house per month to the family of 15530 beneficiaries (to be taken up in 11 coastal districts) during the reconstruction of insitu houses for a period of 7 months under Rajiv Gandhi Rehabilitation Package as 45 packages have already been approved and cleared and the commencement of the construction is imminent. During the construction of insitu houses, the families shall be provided with a rent of Rs.500/- per month initially for a period of 7 months, instead of building temporary shelters for them and to provided rental allowance for a period of 12 months at the rate of Rs.500/- per family per month for rural areas.
- 3. The Special Commissioner and Commissioner of Revenue Administration has therefore requested to sanction a sum of Rs. 10,87,10,000/- towards rent at the rate of Rs. 500/- per house for 12 months and one time shifting allowance at the rate of Rs.1000/- per beneficiary for 15530 rural houses, in order to commence the insitu construction of vulnerable house in rural areas under Rajiv Gandhi Rehabilitation Package.
- 4. The Government after careful examination, accept the request of the Special Commissioner and Commissioner of Revenue Administration and accord sanction for a sum of Rs.10,87,10,000/- (Rupees Ten crores eighty seven lakhs and ten thousand only) towards rent at the rate of Rs.500/- per house for 12 months and one time shifting allowance at the rate of Rs.1000/- per beneficiary for 15530 rural houses, in order to commence the insitu construction of vulnerable houses in rural areas under Rajiv Gandhi Rehabilitation Package.
- 5. The expenditure sanctioned in paragraph 4 above shall be debited to the following head of account:-

- " 2216. Housing-80, General-800, Other expenditure Schemes in the Eleventh Five Year Plan-II State Plan JN Tsunami Rehabilitation Works Housing-09, Grants in aid-03, Grants for specific schemes." (DPC 2216 80 800 JN 09 38)
- 6. The Special Commissioner and Commissioner of Revenue Administration is authorized to draw and disburse the amount sanctioned in paragraph 4 above to the concerned District Collectors. The Special Commissioner and Commissioner of Revenue Administration is requested to send the statement of Expenditure Utilisation Certificate and Progress report to the Accountant General/Government.
- 7. The Special Commissioner and Commissioner of Revenue Administration/Officer on Special Duty (Relief and Rehabilitation) is requested to place the matter before the Empowered Committee for ratification.
- 8. This Orders issues with the concurrence the Finance Department vide its U.O.No.14015/Revenue/08, Dated: 15.03.2008.
