## ORDER:

In the letter 1<sup>st</sup> read above, the Director of Rural Development and Panchayat Raj had sent proposals under the Backward Regions Grant Fund (BRGF) for works under Rural and Urban Local Bodies in six BRGF Districts viz., Cuddalore, Dindigul, Nagapattinam, Sivaganga, Thiruvannamalai and Villupuram districts at a total cost of Rs.108.04 crores for the year 2010-2011. The same was placed before the High Powered Committee. After approval of the Committee, it was sent to the Ministry of Panchayati Raj, Government of India for sanction of the proposals of the State Government @ Rs.108.04 crores.

2. The Ministry of Panchayati Raj, Government of India in their orders 2<sup>nd</sup> read above, have released a sum of Rs.95.97 crores (Rupees Ninety Five crores and Ninety Seven lakhs only) to the State Government with a direction to transfer the funds to the Panchayats, the Municipalities and other implementing authorities of the programmes with in 15 days of the release of the funds to the consolidated fund of the state as Development Grants for the year 2010-11 as detailed below.

3. The Government after careful examination accord sanction and order the release of Rs.95,97,00,000 (Rupees Ninety Five crores and Ninety Seven lakhs only) as Development Grant to six Backward Regions Grant Fund districts viz., Cuddalore, Dindigul, Nagapattinam, Sivaganga, Thiruvannamlai and Villupuram.

4. The amount sanctioned in para 3 above shall be debited under the following head of account:

"2515-00- Other Rural Development Programmes – 800. Other Expenditure – Schemes in the Eleventh Five Year Plan – II State Plan KS – Implementation of schemes under Backward Regions Grant Fund – 09-Grants-in-Aid – 03-Grants for Specific Schemes (DPC 2515-00-800-KS-0931)".

5. Necessary additional fund of Rs.5,97,00,000/- over and above the provisions made in Budget Estimate 2010-2011 will be provided in the Revised Estimate / Final Modified Appropriation 2010-11 and pending provision of such funds in Revised Estimate/Final Modified Appropriation 2010-11, the Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount to the District Collectors concerned based on the releases from Government of India. The Pay and Accounts Officer (South) is directed to admit and honour the bill, if otherwise found in order. The expenditure will be brought to the specific notice of the legislature by specific inclusion in the Supplementary Estimate 2010-11. The Director of Rural Development and Panchayat Raj is requested to include this expenditure while sending the proposals for Revised Estimate/Final Modified Appropriation 2010-11 to Government in Finance (RD) Department and send necessary Explanatory Notes for inclusion in the Supplementary Estimates 2010-11.

6. The Director of Rural Development and Panchayat Raj is also directed to instruct the Collectors to transfer the funds as per the instructions contained in para 6 of the release order of Government of India and to maintain accounts as provided in the guidelines on Backward Regions Grant Fund and to send quarterly progress reports to Government of India and State Government.

7. This order issues with the concurrence of Finance Department vide its U.O.No. 220/DS(B)/RD/10, dated 2.11.2010 and with Additional Sanction Ledger No. 1262 (One thousand two hundred and sixty two)
