## **ORDER:**

In the Government letter first read above, the Commissioner of Rural Development and Panchayat Raj has been informed that all preliminary works like selection of beneficiaries etc., shall be completed before March 2012 and physical work shall commence April 2012 onwards as per the guidelines of Indira Awaas Yojana.

- 2. In the letter second read above, the Commissioner of Rural Development and Panchayat Raj has stated that the Government of India have sent the District wise target for the year 2012-13. Totally, 1,11,410 new houses have been allocated to Tamil Nadu under Indira Awaas Yojana for the year 2012-13. As per the target fixed by the Government of India, the State Matching share is Rs.125,33,97,000/- and the State additional grant for RCC is Rs.612,75,50,000/-. The total fund requirement under Indira Awaas Yojana for the year 2012-13 works out to Rs.738,09,47,000/- for the allotment of 1,11,410 houses.
- 3. The Commissioner of Rural Development and Panchayat Raj has therefore requested the Government to sanction a sum of Rs.738,09,47,000/- for the construction of 1,11,410 New houses under IAY for the year 2012-13.

- 4. The Government, after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, sanction and release a sum of Rs.166,54,09,000/- (Rupees One hundred and sixty six crores Fifty four lakhs and Nine thousand only) now i.e., 25% of the Budget provision available in BE 2012-13, towards State share for the construction of 1,11,410 New houses under Indira Awaas Yojana for the year 2012-13.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Accounts:
