## **ORDER:**

The Commissioner of Rural Development and Panchayat Raj in his letter read above, has sent a proposal recommending reimbursement of an amount of Rs.3,09,66,758/- (Rupees three crores nine lakhs sixty six thousands seven hundred and fifty eight only) based on the claims made by the Tamil Nadu Civil Supplies Corporation Limited, towards transportation, handling charges and other expenditure for movement of 47,906 MTs of rice from Food Corporation of India godowns to the retail outlets allotted to Tamil Nadu under Sampoorna Grameen Rozgar Yojana (SGRY) for the year 2007 - 08.

- 2. The Government after careful examination, have decided to accept the proposal of the Commissioner of Rural Development and Panchayat Raj in para 1 above and accordingly, sanction an amount of Rs. 3,09,66,758/- (Rupees three crores nine lakhs sixty six thousands seven hundred and fifty eight only) towards transport charges and other expenditure for 47,906 MTs of rice supplied under Sampoorna Grameen Rozgar Yojana during the year 2007-08 to the Tamil Nadu Civil Supplies Corporation Limited, Chennai.
- 3. The expenditure sanctioned in para 2 above shall be debited to the following head of account.

"2505 Rural Employment 01. National Programmes 702. Jawahar Gram Samridhi Yojana - JA. Sampoorna Grameen Rozgar Yojana - Block Panchayats - 73. Transport charges (DPC.2505 01 702 JA 7305)"

- 4. The expenditure sanctioned in para 2 above shall not be paid in cash but shall be drawn and remitted to the following head of account by presenting an adjustment bill to the respective Pay & Accounts Officer in time.
  - "3456.00 Civil supplies 911 Deduct Recoveries of over payments I Non-Plan AA Refund of excess assistance drawn towards public distribution system support 77. Deduct Recoveries -03. Other recoveries (DPC 3456-00-911-AA-7739)"

- 5. Necessary funds will be provided in Revised Estimate / Final Modified Appropriation 2008-09. Pending provision of funds in Revised Estimate / Final Modified Appropriation 2008-09 the Commissioner of Rural Development and Panchayat Raj is authorized to draw and adjust the amount by presenting an adjustment bill and the Pay and Accounts Officer (South) is directed to admit and honour the bill if otherwise found in order. The Commissioner of Rural Development and Panchayat Raj is requested to include this while sending the proposals for Revised Estimate / Final Modified Appropriation 2008-09. The expenditure will be brought to the specific notice of the legislature by inclusion in the Supplementary Estimate.
