In the letter second read above, the Joint Secretary to Government of India, Ministry of Rural Development has stated that Ministry of Rural Development, Government of India has received a suggestion from NABARD that they would like to use the same Committee for prioritizing projects for RIDF also and that the Ministry of Rural Development, Government of India has accepted the aforesaid suggestion of NABARD. The Joint Secretary to Government of India, Ministry of Rural Development has therefore requested that, the Regional Officer-in-charge of NABARD in Tamil Nadu may be included as a member of the State Level Standing Committee for PMGSY. In the letter 3rd read above, the Deputy General Manager, NABARD has requested that the inclusion of the Regional Officer-in-charge may be as Chief General Manager, Tamil Nadu Regional Office, NABARD.

3. The Government have examined the suggestion of Government of India. Ministry of Rural Development and the request of NABARD referred to in para -2 above and decided to accept the same. The Government accordingly direct that the Regional Officer-in-Charge / Chief General Manager, Tamil Nadu Regional Office, NABARD be included as a member of the existing State Level Standing Committee for PMGSY in this state.
