

Inspection Report of Accountant General - 1993-94 - District Rural Development Agency, Trichirapalli - Non-recovery of revolving fund of Rs.67,182/- from defunct DWCRA group members – Waived.

ORDER:

In the letter first read above, the Project Officer, District Rural Development Agency, Trichirappalli District has stated that while auditing the accounts of the District Rural Development Agency, Trichirappalli District, during 1993-94 the Accountant General had raised an objection indicating that the revolving fund withdrawn by 11 defunct groups under "DWCRA" scheme during the year 1986-87 to 1992-93 amounting to Rs.67,182/- was not remitted back by the defunct groups as detailed below and to take action to recover the amount from them:

2. He also stated that during the period from 1986-87 to 1992-93, out of 630 DWCRA groups activated, 11 groups were sanctioned with revolving fund of Rs.15,200/- each had become defunct. They had drawn amount ranging from Rs.750/- to 15,200/- from the revolving fund sanctioned to the groups and a sum of Rs. 67,182/- was drawn and utilised by the Self Help Groups. The group members who received the revolving fund hail from below poverty line families. Out of 11 defunct groups which had drawn revolving fund, are now lies in different districts due to their place of domicile. (one group in Jeyankondam block relates to Perambalur District. and two groups at Karur and Krishnarayapuram block relates to Karur district and the remaining 8 groups relates to Tiruchirappalli District.) Therefore, the amount could not be recovered from them in spite of strenuous efforts made by him. He has requested the Government to waive the above amount. The Director Rural Development & Panchayat Raj in his letter second read above has also recommended the above proposal of the Project Officer and requested orders of Government.

3. The Government after careful examination has decided to accept the proposal of the Director of Rural Development & Panchayat Raj and order that the irrecoverable amount of Rs. 67,182/- drawn by the DWCRA groups from out of the revolving fund sanctioned to them under DWCRA scheme during 1986-87 to 1992-93 be waived of as a special case.
