ORDER

In the G.O. first read above, the Government sanctioned a sum of Rs.15,00,00,000/-(Rupees Fifteen crores only) to allow upgradation of houses of 30,000 Adi Dravidar families at the rate of Rs.5,000/- per family.

- 2. In his letter second read above, the Director of Adi Dravidar and Tribal welfare has stated that since this is a new scheme, the draft proposal for sanction of the amount from Final Supplementary Estimates of 1994-95 sent to the Government was not included in the Final Supplementary estimates 1994-95. He has therefore requested the Government to include the same in the budget estimate 1995-96 and as the financial year 1994-95 is over, the G.O. may be revalidated. He has also requested the Government to issue an amendment authorising the Collectors to draw the amount and implement the scheme.
- 3. The Government after careful consideration have decided to issue revised orders for implementation of the scheme of upgradation of houses of Adi Dravidar and Tribal Welfare families during 1995-96 since necessary provisions has already been made in Budget Estimate 1995-96.
- 4. The Government accordingly sanction an amount of Rs.15,00,00,000/- (Rupees Fifteen Crores only) for implementation of the scheme of upgradation of houses of 30,000 Adi Dravidar and Tribal families at the rate of Rs.5000/- per family. Under this scheme the repairs of the damaged houses already constructed under National Rural Employment programme, Rural Landless Employment Guarantee Programme and Jawahar Velai Vaippu Thittam shall be taken up.
- 5. The Government direct that the scheme of upgradation of houses of Adi Dravidar and Tribal families shall be implemented through District Rural Development Agencies of Districts under the supervision of Director of Rural Development. The district wise allocation for implementing the above scheme shall be made by the Director of Rural Development and sent to Government for approval. The detailed guidelines for implementation of the scheme by District Rural Development Agencies will be issued by the Director of Rural Development separately.
- 6. The Director of Rural Development shall draw and disburse the amount sanctioned in para 4 above to the District Rural Development Agencies based on the district-wise allocation approved

by the Government.

- 7. The expenditure sanctioned in para 4 above should be debited to "2225 welfare of scheduled castes and scheduled tribes and other Backward Classes 01. Welfare of Scheduled Castes 288. Housing- Schemes in the 8th Five year plan-II. State plan-JS. Upgradation of Houses of Rural Adi- Dravidar 09. Grants in Aid (DPC 2225-01-282-JS-0903)".
