ORDER:

In the letter 1st read above, the Commissioner of Rural Development and Panchayat Raj has sent Backward Regions Grant Fund (BRGF) Plans of Rural and Urban Local Bodies of 6 BRGF Districts viz., Cuddalore, Dindigul, Nagapattinam, Sivaganga, Thiruvannamalai and Villupuram districts at a total cost of Rs.216.19 crores (Rs. 108.15 crores for the year 2007-08 and Rs.108.04 crores for the year 2008-09). The same has been placed before the High Powered Committee. After approval of the Committee, it has been forwarded to the Ministry of Panchayati Raj, Government of India for sanction of Rs.216.19 crores in the D.O. letter 2nd read above.

2. Now, the Ministry of Panchayati Raj, Government of India in the orders 3rd read above, have sanctioned and released a sum of Rs.97,21,00,000/- (Rupees ninety seven crores twenty one lakhs only) to six Backward Regions Grant Fund districts as Development Grant for the year 2007-08 as follows:

- 3. The Government after careful examination, accord sanction and order the release of Rs.97,21,00,000/- (Rupees ninety seven crores and twenty one lakhs only) as Development Grant to the six Backward Regions Grant Fund districts viz., Cuddalore, Dindigul, Nagapattinam, Sivaganga, Thiruvannamalai and Villupuram.
- 4. The amount sanctioned in para 3 above shall be debited under the following head of account:

"2515-00- Other Rural Development Programmes - 800. Other Expenditure - Schemes in the Eleventh Five Year Plan - II State Plan KS- Implementation of schemes under Backward Regions Grant Fund - 09-Grants-in-aid - 03-Grants for Specific Schemes (DPC 2515-00-800-KS-0931)".

- 5. Necessary additional funds will be provided in Revised Estimate/Final Modified Appropriation 2009-10. Pending provision of such funds in Revised Estimate/Final Modified Appropriation 2009-10, the Commissioner of Rural Development and Panchayat Raj is authorized to draw and disburse the amount to the District Collectors concerned as released by Government of India. The Pay & Accounts Officer (South) is directed to admit and honour the bill if otherwise found in order. The Commissioner of Rural Development and Panchayat Raj is requested to include this expenditure while sending the proposals for Revised Estimate/Final Modified Appropriation 2009-10. The expenditure will be brought to the specific notice of legislature by specific inclusion in the Supplementary Estimates 2009-10.
- 6. The Commissioner of Rural Development and Panchayat Raj is requested to instruct the Collectors to maintain accounts as provided in the guidelines on Backward Regions Grant Fund and to send quarterly progress reports to Government of India and State Government.
- 7. This order issues with the concurrence of Finance Department vide its U.O.No.39301/RD/09, dated 10.7.2009 and with Additional Sanction Ledger No.369 (Three hundred and sixty nine).
