### ORDER:

The Government sent Annual Plans of 6 (six) Backward Regions Grant Fund Districts under Development Grant to Ministry of Panchayati Raj, Government of India for sanction of Rs.108.04 crores for 2010-11. The Government of India released a sum of Rs.95.97 crores to the State. Subsequently, in the Government order first read above the Government have released the amount to the implementing authority.

2. The Ministry of Panchayati Raj, Government of India in their sanction orders second read above, have released a sum of Rs.10.29 crores (Rupees Ten crores and Twenty Nine lakhs only) to the State Government with a direction to transfer the funds to the Panchayats, Municipalities and other implementing authorities of the programmes within 15 days of the release of the funds to the consolidated fund of the State, as the balance instalment of allocation under Development Grants for the year 2010-11 as detailed below:-

3. The Government after careful examination, accord sanction and order the release of Rs.10,29,00,000/- (Rupees Ten crores and Twenty Nine lakhs only) as balance instalment of allocation of Development Grant to five Backward Regions Grant Fund districts viz., Villupuram, Thiruvannamlai, Dindigul, Nagapattinam and Sivaganga.

4. The amount sanctioned in para 3 above shall be debited under the following head of account:

"2515-00- Other Rural Development Programmes – 800. Other Expenditure – Schemes in the Eleventh Five Year Plan – II State Plan - KS – Implementation of schemes under Backward Regions Grant Fund – 09-Grants-in-Aid – 03-Grants for Specific Schemes (DPC 2515-00-800-KS-0931)".

5. This expenditure will be met from the provisions made in Revised Estimate 2010-11. The Commissioner of Rural Development and Panchayat Raj is authorized to draw and disburse the amount to the District Collectors concerned based on the releases from Government of India. The Pay and Accounts Officer (South) is directed to admit and honour the bill, if otherwise found in order. The expenditure will be brought to the notice of the legislature by specific inclusion in the Supplementary Estimate for 2010-11. The Commissioner of Rural Development and Panchayat Raj is requested to include this expenditure while sending the proposals for Final Modified Appropriation 2010-11 to Government in Finance (RD) Department and send necessary Explanatory Notes for inclusion in the Supplementary Estimate 2010-11.

6. The Commissioner of Rural Development and Panchayat Raj is also directed to instruct the Collectors to transfer the funds as per the instructions contained in para 6 of the release order of Government of India and to maintain accounts as provided in the guidelines on Backward Regions Grant Fund and to send quarterly progress reports to Government of India and State Government. 7. This order issues with the concurrence of Finance Department vide its U.O.No. 25/JS(PM)/2011 dated 21.1.2011.
