## ORDER:

The Government sent Annual Plans of 6 (six) Backward Regions Grant Fund Districts under Development Grant to Ministry of Panchayati Raj, Government of India for sanction of Rs.108.04 crores for 2010 -11. The Government of India released a sum of Rs.95,97,00,000/- as 1<sup>st</sup> instalment to the State. Subsequently, in the Government order 1<sup>st</sup> read above the Government released the above amount of Rs.95,97,00,000/- to the implementing authority. The Government of India have also released a sum of Rs.10,29,00,000/- to Tamil Nadu as 2<sup>nd</sup> instalment of funds against the balance allocation / supplementary district plans 2010-11 of 5 BRGF Districts except Cuddalore which was inturn released by the State Government in the Government order 2<sup>nd</sup> read above.

- 2. Now, the Ministry of Panchayati Raj, Government of India in its sanction order 3<sup>rd</sup> read above, have released a sum of Rs.1,78,00,000/- (Rupees One crore and seventy eight lakhs only) against the plan of Cuddalore, 2010-11 with a direction to transfer the funds to the Panchayats, Municipalities and other implementing authorities of the programmes within 15 days of the release of the funds to the consolidated fund of the State, as the balance instalment of allocation under Development Grants for the year 2010-11.
- 3. The Government after careful examination, accord sanction and order the release of Rs.1,78,00,000/- (Rupees One crore and seventy eight lakhs only) as balance instalment of allocation of Development Grant against the plan of Cuddalore 2010-11.

4. The amount sanctioned in para 3 above shall be debited under the following head of account:

"2515-00- Other Rural Development Programmes – 800. Other Expenditure – Schemes in the Eleventh Five Year Plan – II State Plan - KS – Implementation of schemes under Backward Regions Grant Fund – 09-Grants-in-Aid – 03-Grants for Specific Schemes (DPC 2515-00-800-KS-0931)".

- 5. The above expenditure will be met from the provisions made in Final Modified Appropriation 2010-11. The Commissioner of Rural Development and Panchayat Raj is authorized to draw and disburse the amount to the District Collector concerned based on the release from Government of India. The Pay and Accounts Officer (South) is directed to admit and honour the bill, if otherwise found in order. The expenditure has been brought to the notice of the legislature by specific inclusion in the Final Supplementary Estimate for 2010-11.
- 6. The Commissioner of Rural Development and Panchayat Raj is also directed to instruct the Collector to transfer the funds as per the instructions contained in para 6 of the release order of Government of India and to maintain accounts as provided in the guidelines on Backward Regions Grant Fund and to send quarterly progress reports to Government of India and State Government.
- 7. This order issues with the concurrence of Finance Department vide its U.O.No.43/JS(PM)/2011, dated 11.02.2011.
