### **ORDER:**

In the Government order first read above, orders were issued sanctioning additional 50 litres of fuel to each of the two jeeps available at the block level to six Phase-I Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) districts in the context of inspection of large number of works taken up in all villages under Mahatma Gandhi National Rural Employment Guarantee Scheme and in the Government order second and third read above, this was extended to Phase II and Phase III Mahatma Gandhi National Rural Employment Guarantee Scheme districts. When the scheme was extended to Phase III districts, the Government had also sanctioned 75 litres of fuel additionally per month over and above the existing allocation of 125 litres for the jeep of the Assistant Executive Engineers of Rural Development and Panchayat Raj Department to all districts in Tamil Nadu except Chennai.

2. The Director of Rural Development and Panchayat Raj in his letter fourth read above, has stated that MGNREGS was introduced in all districts except Chennai in a phased manner from the year 2005-2006 and more number of workers register themselves seeking employment day by day and works are undertaken in each and

every Village Panchayat in the State. Since inception of the scheme, the number of works taken up and the expenditure incurred under MGNREGS are raising year after year as detailed below:

Block Officials and Technical Officers have to inspect all the works under the scheme regularly and frequently. It is found that the existing allotment of 200 litres per month per Block Jeep and 200 litres per month for Assistant Executive Engineer is not sufficient for the effective monitoring due to the increasing number of works in all Panchayats.

3. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue orders sanctioning an additional allotment of 50 litres per month for each of the two jeeps in the Blocks (raising the monthly ceiling from 200 litres to 250 litres) and 75 litres per month for the jeeps of Assistant Executive Engineers (raising the monthly ceiling from 200 litres to 275 litres) and informed that the expenditure will be met from 6% administrative cost under MGNREGS.

4. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, sanction an additional allotment of 50 litres per month for each of the two jeeps in the Blocks (raising the monthly ceiling from 200 litres to 250 litres) and 75 litres per month for the jeeps of Assistant Executive Engineers (raising the monthly ceiling from 200 litres to 275 litres) of all MGNREGS districts and the expenditure on this account shall be met from 6% administrative cost under MGNREGS. This order shall take effect from the date of issue of orders.

5. This order issues with the concurrence of Finance Department vide its U.O.No. 3053/FS/P/2010 dated 08.12.2010.
