### **ORDER:**

- (ii) Madras Institute Development Studies undertake studies and research pertaining to development problems, with special reference to the agro-rural aspects of Tamil Nadu and the socially and economically backward sections of the population throughout the country and therefore the representative of Madras Institute of Development Studies, 79, II-Main Road, Gandhinagar, Adyar, Chennai may be nominated as a member representing Reputed Academic Institution.

The Government after careful examination accept the proposal of Managing Director, Tamil Nadu Corporation for Development of Women Limited at para 2 above and accordingly nominate the Representative of Confederation of Indian Industry and the Representative of Madras Institute of Development Studies as members representing of Industrial Federation and Reputed Academic Institution respectively in the Empowered High Level Committee constituted in the Government Order read above.
