NOTIFICATION.

In exercise of the powers conferred by sub-section (1) of section 21 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 (Central Act 42 of 2005), the Governor of Tamil Nadu hereby makes the following amendments to the Rural Development Department notification No: II (2) / RUL / 79 (c) / 2006, published in part II – Section-2 of the Tamil Nadu Government Gazette Extraordinary, dated the 3rd February 2006.

AMENDMENTS.

In the said Notification,-
