9.1 1997-98 – Release of Rs.20 lakhs as first instalment subsidy for implementation of National Project on Biogas Development

ORDER

The Government of India have fixed a physical target of 2000 biogas plants under National Project on Biogas Development for 1997-98. In their reference second read above, the Government of India have sanctioned a sum of Rs.20 lakhs towards first instalment of Central subsidy for implementation of National Project on Biogas Development during 1997-98.

- 2. Sanction is accorded for release of a sum of Rs.20 lakhs (Rupees Twenty lakhs only) being the first instalment of Central subsidy for the implementation of National Project on Biogas Development in Tamil Nadu during 1997-98. The Director of Rural Development is authorised to draw and disburse the amount to the Collectors with reference to the targets fixed and their requirements.
- 3. The amount of advance is towards 50% of the total outlay of each components viz. Central subsidy, Service charges, Turn-key, Job fee for sanitary toilet linked. Biogas plants training courses and staff support of Rs.3000/- per plant for the State.
- 4. The expenditure sanctioned in para 2 above should be debited to '2810-Non-Conventional Sources of Energy 01. Bio-energy 102. Community and Institutional Biogas Development Schemes in the Ninth Five Year Plan III. Centrally Sponsored SA. Installation of Biogas Plants-09. Grants-in-aid" (DPC No.2810 01 102 SA 0903).
- 5. The Director of Rural Development shall forward a copy of the proceedings in which the target, financial allocation and funds released now district-wise to the Government of India and Planning and Development Department and Rural Development (P2) Department early.
- 6. The funds shall be utilized for the allocated targets of various items in accordance with the approved pattern of assistance and instructions/guidelines as contained in the administrative approval, issued by Government of India, Ministry of Non-Conventional Energy Sources, Rural Energy Programme (Biogas Division), in their letter No.5-5/07-BG., dated:21.5.97.
- 7. The funds sanctioned above is provisional and is subject to final adjustment on the basis of audited figures of actual expenditure incurred exclusively on each items of National Project on Biogas Development during 1997-98. The Director of Rural Development shall furnish the actual figures of expenditure duly audited and Utilisation Certificates of each item of National Project on Biogas Development mentioned in Annexure of the Administrative Approval of respective Agencies as early as possible. The funds sanctioned for various items of National Project on Biogas Development is subject to no interadjustment.
- 8. The Claims for various items in the prescribed formats in respect of biogas plants to be set up during 1997-98 shall be sent latest by 30.9.98. The time schedule for submission of claims/Utilisation Certificates of previous years (vide para 9 of Administrative Approval) should be strictly adhered to, to enable the release of second instalment.
- 9. The Director of Rural Development shall regularly keep this Government and the Government of India informed about the number of biogas plants installed and item-wise expenditure incurred.
 - 10. Random checks from time to time should be conducted to see that the Completion

Certificates are issued correctly and the plants have been actually installed.
