

2.11 Maintenance of PMGSY Roads – 2003-04-Allocation of Rs.1.40 crores from State Finance Commission Grant

ORDER

Government of India have launched Pradhan Mantri Gram Sadak Yojana on 28th December 2000. In Tamil Nadu in the first phase, 2000-2001 862 works had been taken up to cover 1442.12 Kms and in the second phase during 2001-2002, 450 works had been taken up to cover 808.60 Kms. For 2000-2001 and 2001-2002 Rs. 153.49 crores and 114.33 crores respectively have been released by Government of India to Tamil Nadu.

2. The guidelines of Pradhan Mantri Gram Sadak Yojana, require the cost of maintenance of such roads to be met from the State Government Funds. A sum of Rs. 1.40 crores is required for maintenance of roads taken up under Pradhan Mantri Gram Sadak Yojana for the first two phases. The State Level Standing Committee in its meeting held on 17.10.03 has approved to seek separate budgetary allocation for maintenance of Pradhan Mantri Gram Sadak Yojana Roads.

3. The Government have examined the proposal in detail and considered that it is the responsibility of the Panchayat Raj Institutions to maintain the, rural roads under their control for which State Finance Commission Devolution / Central Finance Commission grants and other discretionary grants are transferred to them. The Government therefore direct the Director of Rural Development to allocate the requirement of Rs. 1.40 crores (Rupees one crore and forty lakhs only) for the maintenance of Pradhan Mantri Gram Sadak Yojana roads laid in the phases in 2000-2001 and 2001-2002 first from the State Finance commission devolution towards all the three tiers in respect of the district in which the works are done and to distribute the balance State Finance Commission devolution based on the formula accepted by the Government.
