## **ORDER**

The Special Project under Swarnajayanthi Gram Swarozgar Yojana on Intensive Training and livelihood supports in Finfish case Culter and value addition to fish catch for fisher flak in the Coasted Districts of Tamil Nadu of Director of Fisheries sent by the Director of Rural Development in the letter first read above was forwarded to Government of India for sanction of the Project under Swarnajayanthi Gram Swarozgar Yojana. (Special Project)

- 2. The Government of India in their letter second read above, have sanctioned the Special Project with the following conditions.
  - 1. Establish Post project management structure to ensure sustainability of the livelihood activities and the beneficiaries must be put in place by the project implementation agency from the Project.
  - 2. The Release of Funds for the projects be subjected to be required Physical progress and bench mark.
  - 3. The total approval cost of the project is Rs.13,79,49,000 (Rupees Thirteen Crores Seventy Nine lakhs and forty Nine Thousand Only), comprising the Central Share of Rs.1,034,062 lakhs and State share of Rs.344.87 lakhs. The Central share would be released in three installments in the ratio of 40:40:20.
  - 4. The project will be implemented in 12 Tsunami affected District of Tamil Nadu.
  - 5. The funds will be released to the Project Director, District Rural Development Agency, Thiruvallur.
  - 6. The Funds released for the project should be maintained in a separate Bank Account. No fund would be kept in fixed deposit. The interest accrued on the amount deposited in Bank for this project would be used only for this project.
  - 7. The Grant-in-aid shall be utilized for the purpose for which it has been sanctioned and shall not be diverted for any other purpose.
  - 8. Un-spent amount if any, shall be promptly refunded to Government of India with @6% per annum from the date of release of grant-in-aid above.
  - The state Government should be released its share within a fortnight after the date of release of the central assistance and endorse a copy of release order to the Ministry of Rural Development, Government of India.
  - 10. The Project period would be three years from the date of sanctioned of the project.
  - 11.Documentation should be an inherent part of the project along-with the Video recording giving the status of areas of beneficiaries before and after the project. It should cover the details of deliverables as indicated in the project and achievements made against these deliverables.
  - 12.No cost escalation will be permitted for the project. Escalation, if any would be borne by the state Government.

- 13. For the purpose of Monitoring and Evaluation, two committees would be constituted. At the State level the committee will be headed by the Secretary (Rural Development Department) and the District Level Committee will be headed by the Project Director.
- 14. The Implementing agency / Co-ordinating Agency shall submit the Physical and Financial progress report of the project by 15<sup>th</sup> of the month succeeding every Quarter in the monitoring format. Failure to furnish the progress report would make the implementing / Coordinating Agency liable to refund of the Central Funds.
- 15. 2<sup>nd</sup> Installment of funds will be released subject to the following conditions.
  - a. Submission of the utilization certificate of 60% of the total available funds.
  - b. Submission of audit report of the funds utilized.
  - c. Regular reporting of the progress and
  - d. A certificate from the implementing / Co-ordinating Agency that the project is implemented as per the project proposal.
  - e. A certificate from the implementing Agency regarding smooth mobilization of the credit to the project.
  - f. Release of second and third installment of funds will be subject to submission of documental requirements for which detailed guidelines are given.
- 16. The release of funds is subject to Internal Audit of the Ministry of the Rural Development Department.
- 17. It shall be open to the Ministry of Rural Development to prescribe such conditions, as it deems fit from time to time ensure proper execution of the project.
- 3. The Government of India have released a sum of Rs.4,13,84,800 (Rupees Four Crores Thirteen Lakhs Eighty Four thousand and Eight hundred only) as first installment of Central Share (40%) to the project Officer, District Rural Development Agency, Thiruvallur.
- 4. The Government after careful examination approve the implementation of the Project with following conditions.
  - a) The Project shall be implemented in accordance with the conditions laid down by Government of India in the Sanction order.
  - b) The District Rural Development Agency, Thiruvallur will be the Nodal District for the project.
  - c) The Project will be implemented by the Director of Fisheries with the assistance of the Assistant Director of Fisheries and the C & C / project Officers of District Rural Development Agencies of the Districts concerned inter se allocation of funds among the Districts shall be made by the Director of Fisheries.
  - d) The Director of Fisheries shall furnish necessary progress report both Physical and Financial as required by Government of India. The Project Officer, District Rural Development Agencies and the nodal district shall furnish physical / financial progress reports / utilization certificates to the State Government and the Government of India.
  - e) The Director of Fisheries shall send suitable proposals for constitution of a state level Profiteering Committee for the project.
  - f) No cost escalation will be permitted.
