Functions of the Committee

- The Committee will examine the necessity of Rural Roads Project proposals placed before it by Director of Rural Development.
 - 2. The committee will review and monitor the progress of the Implementation of approved projects.
 - 3. The Committee will also evaluate the release of funds by Government of India, maintenance of accounts at the State and District Level.
 - 4. The Committee will review the functioning of District Programme Implementation units on the execution of National Rural Road Programme.
- B) The Committee will review quarterly the following items and send copies of the proceedings to Government of India.
 - (i) Progress of on going works.
 - (ii) Quality Control.
 - (iii) Capacity enhancement and training of executing agency.
 - (iv) Progress in computerised online monitoring.
 - (v) Budgeting of Maintenance funds as per PMGSY guidelines.
 - (vi) Land width availability for roads.
 - (vii) Forests and Environmental clearance.
 - (viii)Provision of public transport on PMGSY roads created etc., and
 - (ix) Road safety issues.
