## **ORDER**

The Director of Rural Development and Panchayat Raj has requested the Government to issue orders for the purchase of a new Ambassador car for the Project Officer, District Rural Development Agency, Sivaganga as per the DGSD Rates, after replacing the old vehicle TCA 1170.

- 2. The Government of India in their letter 1st read above, have delegated the power of approval for replacement of existing vehicles by District Rural Development Agencies to the State Rural Development Secretaries. The Government of India have stated that the Secretary, Rural Development Department of the State may accord approval for such proposals in consultation with the State Finance Department subject to the following conditions:
  - i) The expenditure for procurement of vehicle shall be met from within 30% of the salary costs allotted towards contingencies. In case the expenditure exceeds this limit, the excess expenditure shall be fully met by the State Government.
  - ii) This proposal shall have approval of the Governing Body of the District Rural Development Agency.
  - iii) Proposal shall be accompanied by condemnation certificate of the discarded vehicle issued by the competent authority.
- 3. The Project Officer, District Rural Development Agency, Sivaganga has reported that the expenditure for procurement of vehicle shall be met from within 30% of the salary cost allotted towards contingencies. The Project Officer has further reported that the Governing Body of District Rural Development Agency in its Resolution No.15, dated 13.6.2003 has approved the proposal for replacement of Ambassador Car. The Project Officers has also sent the condemnation certificate for the vehicle TCA 1170 issued by the Director of Motor vehicles and Maintenance Organisation.
- 4. The Government in the G.O. 4th read above have approved the purchase of Ambassador ISUZU / MPFI Petrol /Diesel Non-A/C Car for the Regional Level Officers in the Grade of Additional Director / Joint Commissioner / Deputy Director / Joint Registrar and District Revenue Officers. The Project Officer, District Rural Development Agency will come under this classification.
- 5.In the circumstances stated above, the Government after careful examination accord their sanction for the purchase of a new Ambassador ISUZU / MPFI Petrol /Diesel Non-A/C car to the Project Officer, District Rural Development Agency Sivaganga as per DGSD rates.
- 6. This order issues with the concurrence of Finance Department vide its U.O.No.6092 / Finance(RD)/2007, dated 23.2.2007.
