ORDER

In the G.O. read above orders were issued constituting District Programme Implementation Unit in all the Districts for implementing National Rural Road Programme (NRRP) under Prime Minister's Gramodya Yojana. The National Rural Road Programme has been renamed as Pradhan Mantri's Gram Sadak Yojana (Prime Minister's Gram Sadak Yojana)

- 2. In the 5th meeting of the State Level Standing committee held on 18.01.2001 in Agenda (Agenda No. 8) regarding introduction of the system similar to Highways Department in regard to tenders was discussed. One of the decision taken was to constitute a Commissionerate of Tender to expedite finalisation of tenders in regard to implementation of work under PMGSY. It was decided in the meeting to constitute a Commissionerate of Tender (COT). Accordingly the Director of Rural Development in the reference 2nd read above has sent proposal for the constitution of a Commissionerate of Tender with the members as under.
 - 1. Commissioner of Rural Development
 - 2. Chief Engineer (Highways and Rural works)
 - 3. Special Secretary / Additional Secretary (Finance)
 - 4. Superintendenting Engineer (Rural Development) of the Commissionerate of Rural Development
 - 5. Financial Adviser and Chief Accounts Officer of Commissionerate of Rural Development
 - 6. Project Officer, District Rural Development Agency of the respective District
 - 7. Executive Engineer (Rural Development of the respective District) Special invitee

The Commissioner of Rural Development has also suggested that the Commissionerate of Tender may be delegated with powers. All tenders in PMGSY having value above Rs.2.00 Crores and upto Rs.5.00 Crores and tenders with tender excess more than 5% but not exceeding 10% over estimate value will be decided by the Commissionerate of Tender.

- 3. The Government have carefully examined the proposals of Rural Development in regard to constitution of Commissionerate of Tender in the 2 above and issue the following orders.
- A) A Commissionerate of Tender is constituted with the following members with immediate effect.

- (B) All tenders in PMGSY having value above Rs. 2.00 Crores (Rupees two crores only) and upto Rs.5.00 Crores (Rupees five crores only) and tenders with tender excess more than 5% but not exceeding 10% over estimate value will be decided by the Commissionerate of Tender.
