In the Government Order first read above orders were issued for according Administrative Sanction for Rs.621.58 lakhs for covering 30.875 km, length of roads and 61 cross drainage works in Nagapattinam District.

In the reference second read above, the Director of Rural Development and Panchayat Raj has reported that out of the five works in the package TN-09-06, the tender amount quoted by the contractor was less in four works and excess in one work namely "Improvements to Alakudi – Kaduvetti Road Km, 0/0 - 1/0" than the estimated cost. The overall tender premium in this package is 1.01% less than the estimated rate. The Completion Report for the above package submitted by the Executive Engineer (Rural Development) has been scrutinized and approved subject to the condition that the excess amount of Rs.55,206/- over the Administrative Sanction amount for the work of "Improvements to Alakudi - Kaduvetti road km 0/0 -1/0" should be paid only after getting Revised Administrative Sanction from the competent authority, since all the other works were completed well within the sanctioned amount.
