5.2 Creation of Sanitation Cell at the Directorate with one post of Additional Director and one post of Social Scientist in the cadre of Divisional Development Officer

ORDER

An Integrated Rural Sanitation Programme has been launched by Government of India in 1986-87 with an object to provide sanitation facilities to 25% of the rural population. The programme is under implementation in the State and so far 57356 household latrines have been constructed upto March'94. The government of India and the State Government have decided to give great thrust to the implementation of this programme in the years to come.

2. In the reference 2nd read above Government of India requested this State Government to form a State Level Sanitation Cell for smooth implementation of the Central Rural Sanitation Programme and to achieve the target of 25% coverage of sanitation in rural areas. Government of India has indicated that the cost of establishment of the Sanitation cell could be met from the 3% of Central Rural Sanitation Programme funds allotted to the State for administrative cost. Beside, UNICEF, who is assisting the Intensive Sanitation Programme in Periyar District has also indicated that they will meet the salary support for establishment of a Sanitation Cell upto 1995, besides extending material support needed for effective functioning of the Cell both hardware and software. Accordingly the Director of Rural Development in the reference 3rd read above has sent proposal for creation of a Sanitation Cell at the Directorate with one post of Additional Director of Rural Development and one post of Social Scientist in the cadre of Divisional Development Officer.

3. After careful consideration of the proposal of the Director of Rural Development and since there are consents for funding; the Government accord sanction for creation of a State Level Sanitation Cell temporarily for a period of one year from the date of its formation with the following posts at the Directorate of Rural Development to monitor implementation of Central Rural Sanitation Programme in this State.

 One post of Additional Director of Rural Development in the scale of pay of Rs.4500-150-5700;

and

(2) One post of Social Scientist in the cadre of Divisional Development Officer in the scale of pay of Rs.2200-75-2800- 100-4000.

The Government also direct that the post of Additional Director of Rural Development (Training) be disbanded and the training subject dealt with by him shall be combined with the officer handling TRYSEM (both being training related). The incumbent who becomes surplus on the abolition of the post of Additional Director of Rural Development (Training) will be utilized for the next post of Additional Director Rural Development Sanitation. The post of Social Scientist created above shall be filled up by redeployment.

4. The Director of Rural Development is directed to draw up a Job Chart for the two posts sanctioned above in the light of guidelines issued in the reference first read above and send the same to Government for approval.

5. The pay and allowances of the post of Additional Director of Rural Development and one post of Social Scientist will be met initially from the State funds and later get reimbursed by the UNICEF, as long as UNICEF assistance is available and later the expenditure will be met from administrative component of Central Rural Sanitation Programme.

6. The Director of Rural Development is also requested to avail the material support both hardware and software offered by UNICEF for implementation of the CRSP Scheme.

7. The expenditure is debited to the following head of account:

"2215. Other Rural Development Programmes 800. Other expenditure – Schemes in the Eighth Five Year Plan - V Schemes Financed by Autonomous Bodies – ZA Central Rural Sanitation Programme with the assistance of UNICEF" 01 Salaries (DPC Code No.2515 00 800 ZA 0101)."
