## 2.3 Constitution of State Level Standing Committee under PMGSY

#### ORDER

Government of India as a major initiative to achieve the total connectivity in rural areas has launched a scheme namely National Rural Roads Programme (NRRP) as a major component of the Pradhan Mantri's Gramodaya Yojana (PMGY) with effective from 2000-2001. In the reference 1st cited, Secretary, Ministry of Rural Development, Government of India has indicated that an allocation of Rs. 46.49 Crore is earmarked for the State of Tamil Nadu under the scheme for the year 2000-2001. Government of India was requested to allocate more funds to the State Government. For effective implementation of National Rural Roads Programme, Government of Tamil Nadu have issued Government orders in the reference 2nd and 3rd read above on the implementation modelities on certain issues

2) Government of India has indicated that a Standing Committee should be set up at the State level to ensure close and effective monitoring of the programme. It is also indicated that the State Government would from time to time forward properly formulated and viable project proposals to the Ministry of Rural Development, keeping in view inter alia also the allocation available to the State. Government of Tamil Nadu having examined this guideline issues the following orders

# (a) Constitution of State Level Standing Committee :

At State level a Standing Committee is constituted to analyse Projects received and forward to Government of India, besides monitoring the implementation of Sanction Projects under National Rural Roads Programme with the following composition:

Chief Secretary : Chairman
Secretary, Finance : Member
Secretary, Rural Development : Member
Secretary, Highways : Member
Secretary, Planning and Development : Member

6. Director of Rural Development : Member Secretary

- 7. Superintending Engineer, Rural Development Engineering wing will be special invitee
- 8. The District Collector concerned will be specially invited when rural roads proposal for their District is considered by the Committee

## (b) Functions of the Standing Committee:

- (a) The committee will examine the necessity of Rural Roads Projects proposals placed before it by Director of Rural Development.
- (b) The committee will review and monitor progress of the implementation of approved projects.

# 2. PMGSY

- (d) The Committee will also evaluate the release of funds by Government of India, maintenance of accounts at the State and District levels.
- (e) The Committee will review the functioning of District Programme Implementation units for the execution of National Rural Roads Programme.

# (c) Meeting of the Standing Committee:

This committee will meet as frequently as possible and atleast once in a quarter for discharging its function.
