## 3.11 Upgradation of 30,000 houses for Scheduled castes / Schedules tribes for Rs.15 Crores - Funds release

## ORDER

In the G.O. first read above the Government sanctioned a sum of Rs.15,00,00,000/- (Rupees Fifteen Crores only) for 1995-96 to allow upgradation of houses of 30,000 Adi Dravidar families at the rate of Rs.5,000/- per family. In the Government order third read above, the Government sanctioned a sum of Rs.15,00,00,000/- (Rupees Fifteen Crores only) for 1996-97 to allow construction of new houses for Adi Dravidar families whose houses constructed during 1989-90 were damaged beyond repair.

2) It has been decided in the plan Finance Committee meeting of Adi Dravidar and Tribal Welfare Department held on 04.04.97 that the scheme of upgradation of houses for Adi Dravidar families may be transferred to Rural Development Department for construction of new houses on the pattern as provided in guidelines 51.7 and 51.8 in the Jawahar Rozgar Yojana Manual (August 1994) as amended from time to time.

3) The Government accordingly sanction an amount of Rs.15,00,00,000/- (Rupees Fifteen Crores only) for implementation of the construction of new houses exclusively for Scheduled Castes / Scheduled Tribes on the pattern as provided in guidelines 51.7 and 51.8 in the Jawahar Rozgar Yojana Manual (August 1994) as amended from time to time, as a separate state scheme for 1997-98.

4) The Government have also considered the dire need to rehabilitate the Adi Dravidars affected in the recent communal clashes in the Amaichiarapatti village in Kamarajar district and have decided to set apart a sum of Rs.8,10,000/- (Rupees Lakhs and Ten Thousand only) towards the total cost of construction of 30 (thirty) new houses to them at a cost of Rs.27,000/- per house out of Rs.15 crores sanctioned in para 3 above. The balance amount of Rs.14,91,90,000/- (Rupees Fourteen crores ninety one lakhs and ninety thousand only) shall be spent in accordance with the orders aforesaid.

5) The expenditure sanctioned in para 3 above shall be debited to a new head of account to be opend under demand 27 Rural Development as detailed below:-

"2515-00- Other Rural Development Programme -102 Community Development – Schemes in the Ninth Five year Plan – II. State Plan – KH. Construction of new houses for Rural Scheduled Castes and Scheduled Tribes – 09. Grants – in – aid" (DPC 2515 00 102 KH 0906)

6) The Director of Rural Development (code No.2601) is the estimating reconciling and controlling authority of the above Head of accounts.

7) The Pay and Accounts Officer / Treasury Officers are requested to open the above new head of account in the accounts

8) The expenditure sanctioned in para 3 above will not constitute a "New Service" and shall however, met initially by an advance from the Contingency Fund orders regarding which will be issued from the Finance(BG.I) Department. The Director of Rural Development shall send and application in the prescribed format to the Finance (BG.I) Department together with a copy of this

order. He is also requested to send an explanatory not regarding the brief description of the scheme, the amount likely to be drawn from the contingency fund as an advance and the amount to be incurred during this year etc. for inclusion in the supplementary estimates for 1997-98 for being brought to the information of the Legislative Assembly.

9) The Director of Adi Dravidar and Tribal Welfare is directed to send necessary surrender proposals to Government in Finance (SW) department for Rs.15 crores (Rupees fifteen crores) under "2225.01.283.J.S upgradation of houses of Rural Adi Dravidars" under Demand 30-Welfare of the Scheduled Tribes and Castes, etc. in revised estimate/final modified appropriation of 1997-98 at the appropriate stages.
