ORDER

In the reference third read above, the Director of Rural Development has reported that he had apportioned the Rs.15 Crores for 1995-96 meant for repairs and Rs.15 crores for 1996-97 meant for reconstruction in the same proportion as adopted by Government of India while making Indira Awaas Yojana allocations for 1996-97 for the 28 districts sanctioned in the Government orders 1 and 2 read above. He has therefore requested to ratify his action mentioned above.

The Government after careful examination ratify the action of the Director of Rural Development in having apportioned the amount of Rs.30 crores sanctioned in the Govt. orders first and second read above and in having allocated the funds district wise for reconstruction of collapsed group houses and repairs to Group houses as indicated in the annexure.
