ORDER

The Collector of Thanjavur District has requested to issue orders for the purchase of a new Ambassador Car as replacement of the old Ambassador car No. TN 49B 0222 for his official use as Chairman, District Rural Development Agency, Thanjavur. The Director of Rural Development and Panchayat Raj has recommended the proposal.

2. The Government of India, in their letter 1st read above, have delegated the power of approval for purchase of a vehicle as replacement of existing vehicles by District Rural Development Agencies to the State Rural Development Secretaries, subject to the following conditions:-

- i) The expenditure for Procurement of vehicle shall be met from within 30% of the salary costs allotted towards contingencies. In case, the expenditure exceeds this limit, the excess expenditure shall be met by the State Government.
- ii) The proposal shall have approval of the Governing Body of the District Rural Development Agency.
- iii) Proposal shall be accompanied by condemnation certificate of the discarded vehicle issued by the competent authority.

3. The Collector/Chairman, District Rural Development Agency, Thanjavur has reported that the expenditure of procurement of vehicle will be met from within 30% of the contingencies. He has reported that the Governing Body of the District Rural Development Agency in its resolution No.391, dated 25.10.2006 has approved the proposal for purchase of a new Ambassador 1800 ISZ MPF1 BS II Petrol Car as replacement of the existing Ambassador Car No. TN 49B 0222. He has also sent the condemnation certificate for the Ambassador Car No. TN 49B 0222 issued by the Director of Motor Vehicle Maintenance Organisation.

4. The Government after careful examination have decided to accept the proposal and accordingly order to condemn the Ambassador Car No. TN 49B 0222 and to permit the Collector/ Chairman, District Rural Development Agency, Thanjavur to purchase a new Ambassador Car 1800 ISZ MPFI BSII petrol car as per DGS&D rates as replacement for the condemned vehicle.
