#### ORDER

In the Government Orders first and fourth read above, orders were issued, sanctioning Rs.1.00 crore and Rs.17.30 crore for the years 2005-06 and 2006-07 respectively being the State share to meet the cost of unemployment allowance, administrative expenses of State Council and one-fourth of material cost, by debiting the expenditure under the heads of accounts mentioned in para 4 thereat.

2. The Director of Rural Development and Panchayat Raj in his letter second read above has requested orders of Government to provide a new service head of account as indicated in para 4 of the GOs. first and fourth read above.

3. After the introduction of separate rural schedule of rates, the implementation of the scheme has gained momentum in the districts. Further in the G.O. fifth read above, the Tamil Nadu State Employment Guarantee Council has been constituted. Hence the funds referred to in para 1 above must be available to the Director of Rural Development and Panchayat Raj to meet the State share of expenditure.

4. After considering the above, the Government permit the Director of Rural Development and Panchayat Raj to draw the funds of Rs.18.30 crores (Rs.1.00 crore + Rs.17.30 crore) sanctioned already in the orders first and fourth read above and that the expenditure shall be debited under the following service head of account.

"2505 - Rural Employment - 01. National Programmes - 800. Other Expenditure - Schemes in the Tenth Five year Plan - II. State Plan - JA. National Rural Employment Guarantee Scheme - 09. Grants-in-aid -03. Grants for Specific Schemes (DPC No.2505-01-800-JA-0939).

5. Necessary funds will be provided in RE/FMA 2006 -07. The Director of Rural Development and Panchayat Raj is requested to include above expenditure while sending proposals for RE/FMA 2006-07.

6. The Government also authorize the Director of Rural Development and Panchayat Raj to draw funds from the Tamil Nadu State Employment Guarantee Fund to meet the expenditure on implementation of Tamil Nadu Rural Employment Guarantee Scheme like payment of State share, unemployment allowance, administrative expenses of State Council and one fourth of material cost of works taken up under this scheme.

7. The Accountant General is requested to make necessary transfer entries to the Fund Account .
