### **ORDER:**

The Commissioner of Rural Development and Panchayat Raj has proposed for construction of Community Green Sanitary Complex at a total cost of Rs.113.00 lakhs in 14 places in the districts which rank low in sanitary habits.

2. The Standing Finance Committee has approved the above proposal under Part-II Schemes for the year 2013-14.

3. Sanction is, therefore, accorded for a sum of Rs.113,00,000/- (Rupees One Crore and thirteen lakhs only) as non-recurring expenditure for the Construction of Community Green Sanitary Complex in 14 places in the districts which rank low in sanitary habits under Part II scheme for the year 2013-14.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account:-

5. The Commissioner of Rural Development and Panchayat Raj, Chennai is authorized to draw and incur the expenditure sanctioned in para 3 above and he is requested to send the Utilization Certificate and the work completion certificate to Government within the prescribed time.

6. The Commissioner of Rural Development and Panchayat Raj shall follow the existing rules in force for the Construction of Community Green Sanitary Complex in 14 places in the districts which rank low in sanitary habits.
