cited:

AMENDMENT

(1) After the table in para 5 of the Government Order 2nd cited, the following
paras shall be inserted as paras 6 and 7:

6. "The wage for outturn/day which is more than the prescribed outturn will also
be capped at the minimum wage i.e. Rs.100/- per day.

7. The labourers shall also be entitled to an additional wage of 10% of the wage rate if they fulfill the conditions prescribed in para 14 read with para 12 of Schedule II of NREG Act, 2005.”

(2) The existing paras 6, 7 and 8 shall be renumbered and read as paras 8, 9 and 10.
