ORDER:

In exercise of the powers conferred under section 27 of the National Rural Employment Guarantee Act, 2005 the Central Government directed the State Government to set up the office of the Ombudsman for redressal of grievances in a time bound manner. As per the instructions of the Ministry of Rural Development, Government of India, necessary orders have been issued in the Government Order second read above for the establishment of the Office of the Ombudsman for redressal of grievances under Mahatma Gandhi National Rural Employment Guarantee Scheme in which procedure for selection, qualification, tenure, territorial jurisdiction etc., regarding the appointment of Ombudsman have been prescribed.

2. In pursuance of Government Order second read above, in the letter third read above, the Commissioner of Rural Development and Panchayat Raj has sent the list of eligible candidates for the appointment of Ombudsman under Mahatma Gandhi National Rural Employment Guarantee Scheme. In the selection committee meeting under the chairmanship of Chief Secretary held on 25.7.2011, panel of the 11 persons was selected.

3. As per the procedures prescribed for appointment of Ombudsman in the Government Order second read above, the panel of Ombudsman was published on the official website (www.tnrd.gov.in) to invite comments from the public. After the expiry of 30 days time from the date of publication in the official website, the Commissioner of Rural Development and Panchayat Raj has stated that no complaint has been registered either in the official website or any complaint letter has been received. He has therefore requested the Government to issue orders in this regard.

4. The Government, after careful examination, appoint following 11 persons as Ombudsman for redressal of grievances under Mahatma Gandhi National Rural Employment Guarantee Scheme for effective implementation of Mahatma Gandhi National Rural Employment Guarantee Scheme:
