Announcement made by Hon'ble Minister (Municipal Administration & Rural Development) on the floor of the Assembly on 9.4.2012 – Issue of Individual Identity Cards to Self Help Group members in 60 Blocks in 15 Tamil Nadu State Rural Livelihoods Mission Districts – Sanction of balance funds of Rs.1,41,57,575/- - Proposal approved – Orders Issued.

### ORDER:

In the Government Order first read above, orders were issued sanctioning Rs.2.50 Crores (Rs. 1.50 crores for Pudhu Vaazhvu Project and Rs.1.00 Crore for Tamil Nadu State Rural Livelihoods Mission) for issuing individual Identity Cards to Self Help Group members in 60 Blocks in 15 Tamil Nadu State Rural Livelihoods Mission (TNSRLM) Districts and 70 Blocks of Pudhu Vaazhvu Project Self Help Group members and the cost to be incurred within the provision available in Budget Estimate 2012-13 in respect of Mahalir Thittam Project and Pudhu Vaazhvu Project.

2. In the D.O. Letter second read above the Managing Director, Tamil Nadu Corporation for Development of Women Limited has stated that Hon'ble Minister for Municipal Administration and Rural Development had announced in the floor of the Assembly on 09.04.2012 that "Individual Identity cards will be issued to Self Help Group members in 60 Blocks in 15 Tamil Nadu State Rural Livelihoods Mission districts and 70 Blocks of Pudhu Vazhvu Project Self Help Group members at a total cost of Rs.2.50 crores" and she had requested the Government to sanction a sum of Rs.2,41,57,575 for issuing individual Identity Cards to Self Help Group members in 60 Blocks in 15 Tamil Nadu State Rural Livelihoods Mission Districts to be provided from the fund available in the Mahalir Thittam continuance head of account allotted for the year 2012-13. For the Self Help Group members in the 70 Blocks of Pudhu Vazhvu Project, Individual Identity cards will be issued from the funds available with that project.

3. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has further stated that, it is estimated that Rs.25 will be the cost of Individual ID card which includes Data Collection, Photography, Data entry, Printing and Lamination. Hence, a sum of Rs.2,41,57,575 is proposed for issuing identity card to 9,66,303 members of 74,331 Self Help Groups of 60 Tamil Nadu State Rural Livelihoods Mission Blocks under Mahalir Thittam. She has also informed that since the total cost for this

project is less, it is proposed to utilize the balance fund available in the Mahalir Thittam continuance head of account. It is also stated that this amount is not included in the National Rural Livelihoods Mission budget for the year 2012-13. In G.O.(Ms)No.84, Rural Development and Panchayat Raj (CGS-3) Department dated 11.9.2012 orders were issued sanctioning a sum of Rs.1.00 crore for issuing individual Identity Cards to Self Help Group members in 60 Blocks in 15 Tamil Nadu State Rural Livelihoods Mission Districts and Rs.1.50 crores for Pudhu Vaazhvu Project for 70 Blocks of Pudhu Vaazhvu Project. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has stated that it is not possible to issue the identity card to 9,66,303 members of 74,331 Self Help Groups of 60 National Rural Livelihoods Mission Blocks under Mahalir Thittam within the sanctioned amount of Rs.1.00 crore and the announcement made by the Hon'ble Minister cannot be achieved. She has therefore requested the Government to issue necessary orders for the sanction of the balance amount of Rs.1,41,57,575 for issuing individual Identity Cards to Self Help Group members in 60 Blocks in 15 Tamil Nadu State Rural Livelihoods Mission Districts from the balance fund available in the Mahalir Thittam continuance Head of Account.

4. The Government after careful examination of the proposal of the Managing Director, Tamil Nadu Corporation for Development of Women Limited have decided to accept the same and accord sanction for a sum of Rs.1,41,57,575/- (Rupees One crore forty one lakhs, fifty seven thousands, five hundred and seventy five only) towards issuing the individual Identity Cards to Self Help Group members in 60 Blocks in 15 Tamil Nadu State Rural Livelihoods Mission (TNSRLM) Districts. The Government direct that the cost will be incurred within the Budget Estimate 2012-2013 provision and there is no additional funds will be provided in RE / FMA for this purpose and existing Tender procedure has to be followed.

5. The expenditure sanctioned in para 4 above shall be debited under the following heads of account:-
