

**602 Technical and 81 Non-Technical temporary posts - Further continuance
from 01.07.2004 to 31.12.2004**

ORDER

A separate Engineering Wing for Rural Development Department was created with sanction of 602 Technical and 81 non-technical posts totaling to 683 posts for a period of 3 years from 27.12.1996 in the Government Order first read above. Sanction was accorded subsequently for the further continuance of these posts for the period upto 30.6.2004 in the Government Order second, third and fourth read above. The period of continuance of the 683 posts expired on 30.6.2004.

2. The Rural Development Department is implementing various development schemes for the benefit of rural population. As various types of works are being executed by Rural Development Department , it is essential to complete these works in time so that the benefits of these schemes reach the rural the rural population. In order to sustain the speed of work, ensure quality and to achieve the target in the coming years the services of the technical wing of Rural Development Department is absolutely necessary. Hence, the Director of Rural Development has recommended that the continuance of 602 technical and 81 non-technical posts needs to be extended for a further period of three years from 1.7.2004 to 30.6.2007.

3. The Government have examined the above proposal of the Director of Rural Development and they approve the proposal of the Director of Rural Development restricting the period of sanction to six months. They accordingly direct that the 602 technical posts and 81 non-technical posts which are shown in Annexure to this order to be continued for a further period of six months from 1.7.2004 to 3.12.2004 subject to the following conditions:-

- (i) Wherever the surplus is identified to vacant posts in these categories of posts should not be filled up to the extent of surplus identified.
- (ii) Wherever vacancies are found the vacant posts over and above surplus posts should not be filled by direct recruitment.

4. The incumbents of the posts are eligible to draw the Pay and Dearness Allowance and other allowances as admissible under the orders in force.

5. The expenditure relating to the posts mentioned in the Annexure-I shall be debited to "2505. Rural Employment – 01 National Programmes – 702. Jawahar Gram Samridhi Yojana – Scheme in the Tenth Five Year Plan-II State Plan JA Sampoorna Grameen Rozgar Yojana – 01 Salaries. DPC No.2505-01-702-JA-0106".

6.The Collectors are requested to communicate this order to the concerned officers under their control. (including Sub-Treasury Officers)
