### ORDER:

In the Government Orders first and second read above, a Training Corpus Fund was created for imparting systematic and regular training to the elected representatives of Panchayat Raj Institutions and a High Level Committee was constituted for administration of the fund. The Government have also framed guidelines therein to be followed for imparting systematic and regular training to the elected representatives on the Panchayat Raj Administration. The Government have further ordered to allocate Rs.3.00 crores to the Training Corpus Fund, from the State Finance Commission Grant for the year 2007-2008 and 2008-2009 in the ratio of 8:32:60 as detailed below:

1. District Panchayat : Rs.0.24 crores (8%)
2. Panchayat Unions : Rs. 0.96 crores (32%)
3. Village Panchayats : Rs.1.80 crores (60%)

Total : Rs.3.00 crores.

The above amount was ordered to be deducted from the first month allocation out of State Finance Commission Grant for the year 2007-08 and 2008-09.

2. The Commissioner of Rural Development and Panchayat Raj has now stated that the Training Corpus Fund is to be created for the year 2010-2011. The Commissioner of Rural Development and Panchayat Raj has also stated that the Government of India have allocated funds during 2008-2009 to the tune of Rs.16.32 crores under Backward Regions Grant Fund (BRGF) for training the elected representatives of Panchayat Raj Institutions and Officials of Rural Development and Panchayat Raj Department. The Government of India have also sanctioned Rs.2.44 crores under Rashtriya Gram Swaraj Yojana (RGSY) for capacity building activities for Panchayat Raj functionaries. In view of the allocation made under the BRGF & RGSY Schemes during 2008-2009 as explained above, it is sufficient to allocate a lesser amount of Rs.50.00 Lakhs (Rupees Fifty lakhs only) under Training Corpus Fund during 2010-2011, instead of Rs.1.00 crore allocated during 2009-2010, and has requested to issue necessary orders for sanction of Rs.50.00 Lakhs (Rupees Fifty lakhs only) Training Corpus Fund for the year 2010-2011 as detailed below:

1. District Panchayats	: Rs.04.00 Lakhs (8%)
2. Panchayat Unions	: Rs.16.00 Lakhs (32%)
3. Village Panchayats	: Rs.30.00 Lakhs (60%)

3. The Government have carefully examined the above proposal of the Commissioner of Rural Development and Panchayat Raj and decided to accept the proposal. Accordingly the Government direct that an annual allocation of Rs.50.00 Lakhs (Rupees Fifty lakhs only) be made as Training Corpus Fund for the Training Programmes for the year 2010-2011 from the State Finance Commission grant for the year 2010-2011 in the ratio of 8:32:60 as detailed below:

1. District Panchayats	: Rs.04.00 Lakhs (8%)
2. Panchayat Unions	: Rs.16.00 Lakhs (32%)
3. Village Panchayats	: Rs.30.00 Lakhs (60%)

The said amount shall be deducted from the first month allocation, out of State Finance Commission grant for the year 2010-2011.

4. The Commissioner of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in paragraph 3 above.
