NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the rules issued with the Rural Development Department Notification No.SRO B.62/2000 at pages 74 and 75 of Part-III Section 1(b) of the Tamil Nadu Government Gazette, dated 24th May 2000.

2. The amendment hereby made shall come into force on and from the 11.1.2010.

AMENDMENT.

In the said Rules, in rule 4, of THE TABLE, column (2) for item (2) against the entries "(b) Recruitment by transfer from the Junior Engineer and Senior Draughting Officer in the Rural Development Department" in column (1) thereof, the following item shall be substituted, namely: -

“(2) Service for a total period of not less than five years on duty in the Tamil Nadu Rural Development and Panchayat Raj Department as Junior Engineer or as Senior Draughting Officer either separately or in combination as Junior Engineer and Senior Draughting Officer.”
