**ORDER**

The Government have issued orders from time to time approving the list of certain models of Light, Medium and Heavy Operation Vehicles for use in Government Department. In the G.O.1<sup>st</sup> read above as amended in the Government letter second read above a new comprehensive list of vehicles to be purchased by various Government Departments for use was approved based on the recommendations of the Technocrats Committee.

2. Subsequently, certain automobile companies whose vehicles were not included in the approved list of vehicles ordered in the Government order 1<sup>st</sup> read above have represented to the Government and Transport Commissioner for inclusion of their vehicles additionally in the approved list. The Transport Commissioner was requested to place these requests before the Technocrats Committee. The Technocrats Committee in its meeting held on 16/10/2006 has recommended inclusion of certain models of vehicles. The Transport Commissioner has forwarded the reports of the Technocrats Committee for passing appropriate orders.

3. The recommendations of the Technocrats Committee for inclusion of new models additionally in the Government approved list are as follows:
