## 3.17 Deputation of Extension Officer (Accounts) of the Directorate of Rural Development to districts for training for nine months - Modified orders

## **ORDER**

In the Government Order 1st read above, the Government have issued orders reconstituting the Tamil Nadu Panchayat Development Subordinate Service and framed rules including the post of Extension Officers.

2. However, in the Government Order 2nd read above orders have been issued reducing the service qualification of two years training to the Panchayat Union in the post of Extension Officer (Panchayats) and Extension Officer (SS & PR) for one year each as prescribed in the Tamil Nadu Panchayat Development subordinate service Rules for the post of Extension Officer (Accounts) of the Directorate of Rural Development (whose service shall count as service rendered in the post of Extension Officer (Administration) for the purpose of calculating the periods of one year service for promotion as Deputy Block Development Officer) as nine months and further ordered that they should complete the following programme during the said training periods:-

1	Field Training with Extension Officer (Panchayats)	1 Month
2	Field Training with Extension Officer (Animal Husbandry )	1 Month
3	Field Training with Extension Officer (SS&PR)	1 Month
4	Field Training with Deputy Block Development Officer	1 Month
5	Independent Charge as Extension Officer (Panchayats) Extension Officer (SS&PR) and Extension Officer (Animal Husbandry) (i month each)	3 Months
6	Institutional training in any of the Rural Extension Training Centres for Extension Officer (Panchayats)/ Deputy Block Development Officer according to the training calendar of Rural Extension Training Centres concerned.	2 Months

3. The Director of Rural Development in his letter third read above has stated that Government in G.O.(2D) No. 66, Rural Development (E4) Department dated 25.6.2004 issued orders reverting the incumbents of the posts of 212 Extension Officer (Animal Husbandry) as the services of the above posts were not required by Rural Development Department beyond 30.6.2004. The Director of Rural Development has further stated that as per the training schedule issued in G.O. (MS) No. 116, Rural Development (E4) Department dated 17.10.2002, the Extension Officers of the Directorate of Rural Development have to undergo 1 month field training with Extension Officer (Animal Husbandry). Since the Government reverted the post of Extension Officer (Animal Husbandry) to their parent Department, the Director of Rural Development has stated that the Government have to issue orders to delete the one month field training with Extension Officer (Animal Husbandry) and independent charge as Extension Officer (Animal Husbandry) for one month as ordered in G.O.(Ms).No. 116. Rural Development (E4) Department dated 17.10.2002.

The Director of Rural Development has, therefore, requested to issue the following amendment to G.O.(Ms).No. 116. Rural Development (E4) Department dated 17.10.2002. so as to modify the training schedule:-

The Government have examined the proposal of the Director of Rural Development in detail and have decided to modify the 9 months training schedule for Extension Officer (Accounts) working in the Directorate of Rural Development ordered in the Government Order (Ms) No. 116 Rural Development (E4) Department dated 17.10.2002. Accordingly the Government hereby order to modify the 9 months training schedule for the Extension Officer working in the Directorate of Rural Development as follows:-
