

2.104 Reorganization of staff setup at Block level ordered - Retention of left out posts of Assistants - Super numerary posts

ORDER:

In the Government Orders first, third and fourth read above, reorganization of the staff setup at Block level (so as to suit the three tier system of Panchayat administration which came into operation as per the Constitution (73rd Amendment) Act, 1992 and the Tamil Nadu Panchayat Act 1994) into two wings , one headed by the Block Development Officer (Block Panchayats) and the other headed by the Block Development Officer (Village Panchayats) was ordered.

2. In the letter second and fifth read above, the Director of Rural Development stated the following number of posts were left out while prescribing the reorganized staff setup in the G.O. first read above.

Director of Rural Development has also stated that omission of these posts, existing already depending upon the Block to Block variation in area and work load, will cause unnecessary administrative inconvenience and hence requested the Government to accord sanction for retaining them.

3. The Government considered the matter carefully and pass the following orders :-

- (i) the 377 posts of Assistants, 1879 posts of Junior Assistants, 360 posts of Record clerks and 328 posts of Office Assistants at the Block level left out while computing the number of posts for prescribing the reorganized staff setup shall be retained as "Supernumerary posts"
- (ii) incumbents holding the supernumerary posts at present shall be transferred to regular vacancies whenever such vacancies arise or whenever new posts are created. The existing future vacancies of these supernumerary posts shall not be filled up but, shall be disbanded automatically.

2. IMPORTANT G.Os

- (iii) the incumbents of the supernumerary posts of Office Assistant shall work in the Block Panchayat Wing and the incumbent of the supernumerary posts of Record Clerk shall work in the Village Panchayats wing.
- (iv) transfer of the incumbents of the above mentioned supernumerary posts to new posts /regular vacancies shall be monitored by the District Collectors and the Director of Rural Development. A consolidated report shall be sent to the Government by the Director of Rural Development once in six months.

4. Districtwise, and Panchayat Unionwise break up details of the posts mentioned in para 3(i) above will be communicated to all the District Collectors, Assistant Directors and Block Development Officers by the Director of Rural Development.

5. This order issues with the concurrence of the Finance Department vide its U.O.No. 1369/FS/P/2000, dt. 3.5.2000.
