ORDER

In order to strengthen the technical wing in Rural Development Department, the proposal of the Director of Rural Development for providing a full fledged office of a Divisional Engineer / Executive Engineer in each District, a Sub-division headed by Assistant Divisional Engineer / Assistant Executive Engineer in each Division, two Union Engineers per Block and a technical Wing at the Directorate of Rural Development headed by a Superintending Engineer was considered and issued orders sanctioning the following technical and non-technical posts for a period of 3 years from 27.12.1996 in the Government Order first read above:-

It was ordered therein that all the non –technical posts mentioned above should be filled up by way of re-deployment and equal number of equivalent posts should be surrendered by

2. The Director of Rural Development in his letter third read above has stated that all the technical posts have been filled up and from surplus posts sanctioned for other schemes for which continuance accorded in the Government Order second read above for the period upto 30.6.2000 have been redeployed for filling up of non-technical posts. The particulars of the number of posts and the G.O.no and date so sanctioned and now surrendered for the purpose of redeployment in this regard are shown in the Annexure. He has also stated that the services of both the technical and non technical staff are absolutely essential for the implementation of various State and Central Schemes and other regular works in the Rural Development Department and therefore has requested for extension of continuance of technical post from 27.12.99 to 3 years and non-technical posts from 1.7.2000 to 26.12.2002.

3. The Government accept the proposals of Director of Rural Development and direct that the 602 technical posts sanctioned in G.O.(Ms).No.263, R.D.(CSS.1) dt.27.12.96 be continued for the further period from 27.12.99 to 30.6.2001 and 81 non-technical posts be continued for the further period from 1.7.2000 to 30.6.2001. The surplus posts sanctioned for other schemes the particulars of which are shown in annexure are hereby ordered to be surrendered.

4. The Director of Rural Development is requested to review the performance of the technical wing of the Rural Development Department by 30.4.2001 and send a review report to Government well in advance before seeking further continuance of the temporary posts beyond 30.6.2001 sanctioned in this Government Order or otherwise.

5. The incumbents of the posts are eligible to draw the Pay and D.A. and other allowances as admissible under the orders in force.

6. The expenditure relating to the posts mentioned in the Annexure-I shall be debited to "2505 Rural Employment – 01 National Programmes – 702. Jawahar Gram Samridhi Yojana – Schemes in the eighth Five Year Plan-II State Plan JA Jawahar Gram Samridhi Yojana – 01 Salaries. DPC No.2501-01-702-JA-0106".

7. The Collectors are requested to communicate this order to the concerned officers under their control. (including Sub-Treasury Officers)
