## 2.22 Group 'B' Officers up to D.D.O. level deputed to DRDA / TN Corporation for Development of Women - Issue of terms and conditions

## **ORDER**

Group A and B Officers of the category of Additional Director of Rural Development / Join Director of Rural Development / Divisional Development Officers of Rural Development Department are being deputed to other Government Agencies like District Rural Development Agencies, Tamil Nadu corporation for Development of Women by the Government. Terms and conditions for foreign service under rules 110 to 114 of Fundamental Rules and certificate under Fundamental Rule 26(d) are also being issued by the Government for such Officers deputed by them to the other Government Agencies so as to regulate their pay. The Director of Rural Development, in his letter read above has suggested that the power to issue terms and conditions of foreign service under fundamental Rule 110-114 and certificate under Fundamental Rule 26(d) in respect of all categories of Group A and B Officers of Rural Development Department deputed to other Agencies by the Government may be delegated to him, so as to avoid delay in regulating the pay of such Officers.

The Government have examined carefully the above mentioned suggestion of the Director of Rural Development. Mere vesting the responsibility if issuing foreign service terms and conditions etc., in respect of A and B group Officers with Director of Rural Development may not fully eliminate the problem pointed out by the Director of Rural Development. However, having regard to the fact that by the creation of District Rural Development Agencies and District Panchayat in all the Districts, large number of Divisional Development Officers are frequently posted as Assistant Project Officers and Deputy C.E.O.s the Government have decided that the power to issue terms and conditions under Fundamental Rule 110-114 and Certificate under Fundamental Rule 26(d) in respect of Group B Officers up to the level of Divisional Development Officers only be delegated to the Director of Rural Development, subject to the condition that the general terms and conditions / order already issued and to be issued in future by the Government shall be adhered to.

Accordingly, the Government hereby delegate the powers to the Director of Rural Development to issue the terms and conditions of for foreign service under Fundamental Rule 26(d) certificate under Fundamental Rural Development certificate under fundamental Rule 26(d) in respect of Group B Officers up to the level of Divisional Development Officer deputed to other agencies like District Rural Development Agencies, Tamil Nadu Corporation Development of Women etc., by the Government subject to the condition that general term and conditions / orders / to be issued from time to time by the Government should be adhered to. In regarding Officers above the level of Divisional Development Officers, Government will continue to exercise this power.

This order issues with the concurrence of the Personnel and Administrative performs Department vide its U.O No.35284/98-1 P & AR, dated 3.7.98.
