

**3.8 Special Pay to teaching faculty of Rural Extension Training Centre/State Institute of Rural Development on par with the Civil Service Training Institute at Bhavanisagar - surrender of certain posts in RETCs / SIRD**

**ORDER**

In the Government Order read above, Government sanctioned the following rates of special pay to the teaching staff of Rural Extension Training Centres.

2. The Director of Rural Development has reported that the special pay sanctioned by Government to the teaching staff of Rural Extension Training Centre is not adequate and there is no uniformity in sanctioning the special pay. The Director of Rural Development has also proposed to surrender certain posts in the Rural Extension Training Centre/ State Institute of Rural Development. The Director of Rural Development has therefore sent necessary proposal for sanction of special pay to teaching faculty of Rural Extension Training Centre / State Institute of Rural Development and also for surrender of certain posts sanctioned to Training Institutions of Rural Development.

3. After careful examination of the proposal of the Director of Rural Development, Government now direct that the following posts sanctioned to Training Institution of Rural Development be surrendered.

2.	Lecturer in Industries	5 (1 for each Training centre)
3.	Lecturer in Social Forestry	5 (1 for each Training centre)

5.	Film Operator	6 (RETC – 5, SIRD –1)
6.	Artist	2 (RETC,T.Kallupatti-1, SIRD-1)
7.	Assistant Instructors in Home Science wing	4 (RETC, T.Kallupatti – 1 S.V.Nagaram – 3)

4. Out of the above posts orders have been issued for the continuance of only the following staff of Rural Extension Training Centres/ State Institute of Rural Development upto 30.9.93. Government therefore direct that the following posts be surrendered with effect from 30.9.93. after noon.

1.	Lecturer in Industries	5 (1) for each Rural Extension Training Centre
2.	Lecturer in Social Forestry (Assistant Conservator of Forest)	5 (one for each Rural Extension Training Centre)
3.	Film Operator	6 (RETC – 5, SIRD –1)

7. Government also accord sanction for granting Special pay to teaching faculty members on par with the Civil Service Training Institute at Bhavanisagar as detailed below; from the date of issue of the order.
