ORDER

In Government Order first read above, orders were issued framing Special Rules for the Tamil Nadu Panchayat Development Engineering Subordinate Service governing the categories of Overseers and Road Inspectors. The Director of Rural Development in his letter second read above has stated that there are two grades of Road Inspectors viz. Grade I and Grade II working in Panchayat Union. At the time of framing rules, the same was unnoticed and suggested amendments to the Special rules. The amendments suggested by him has been examined and agreed to incorporate in the Tamil Nadu Panchayat Development Engineering Sub-ordinate service Rules.

2. The following Notifications will be published in the TamilNadu Government Gazette

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of TamilNadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Panchayat Development Engineering Subordinate Service (Section 56 in Part III of Volume III of the TamilNadu Services Manual, 1970)

2. The amendment hereby made shall be deemed to have come into force on the 25th day of May 1998.

AMENDMENTS

In the said Rules: -

(1) In rule 1- for the expression "category 2, Road Inspector" the following expression shall be submitted, namely:-

"Category 2, Road Inspector, Grade - I

Category 3, Road Inspector, Grade - II"

(2) In rule 2, in THE TABLE, for the expression "Road Inspector" in column(1) and the corresponding entries in column(2), the following expression shall respectively be substituted namely:-

"Road Inspector Grade-I promotion from Category 3 Road Inspector Grade II Direct recruitment"

- (3) In rule 4,-
 - (i) In sub-rule (a) for the expression "Road Inspector" the expression "Road Inspector Grade-II" Shall be substituted.
 - (ii) In sub-rule (b) in THE TABLE:-
 - (a) for item (2) excluding the provision there under in column (3) against the entry "Overseer" in column (1) and "Promotion" in column (2), the following item shall be substituted namely. "(2) Must have rendered service as Road Inspector Grade —I for a period of not less than five years".
 - (b) for the entries "Road Inspector" in column(1) and the corresponding entries in columns(2) and (3) thereof, the following entries shall respectively be substituted, namely:-

"Road Inspector Grade-I	Promotion	(1) Must possess an I.T.I. Certificate in Civil Draughtsman from a Government recognized institute and
		(2) Must have rendered service as Road Inspector Grade – II for a period of not less than five years.
Road Inspector Grade – II	Direct Recruitment	(1) Must possess an I.T.I. Certificate in Civil Draughtsman from a Government recognized institute

- (4) In rule 8, in sub-rule (a); for the expression "Road Inspector" the expression "Road Inspector", Grade I or "Road Inspector" Grade-II" shall be substituted.
- (5) (4) in rule 10, for the expression "Road Inspector" the expression "Road Inspector Grade Π " shall be substituted.
