## 3.6 Creation of Revolving Fund - delegation of powers - to approve Training budget

## Rural Development (C3) Department

From the Director of Rural Development (Training), Chennai letter No. 38293/2003/Trg. 1, dated 14.8.2003 and even No. dated 21.8.2003 and 22.8.2003.

## **ORDER**

The Director of Rural Development (training ) in the letters read above among others, has requested the Government to approve the following proposals –

- (i) Creation of revoiving fund in the Rural Extension Training Centres;
- (ii) Powers may be delegated to her to approve the budget and proposals within the amount of grants-in-aid (recurring and non-recurring) sanctioned by the Government of India from time to time;
- (iii) Powers may be delegated to the Director of Rural Development (Training) to approve the proposals for improvements to Rural Extension Training Centres within the accumulated balances including interest;
- (iv) Powers may be delegated to the Principals, Rural Extension Training Centres to approve and incur expenditure within the approved budget and approved proposals.
- 2. The Government have examined the above proposal of Director of Rural Development (Training ) referred to in Paragraph I above in detail. The Government accept the above proposal and pass the following orders as indicated below:-

(i) To approve the revolving fund in the RETCs as indicated below:-

The fund is to be recouped from the Government of India's recurring grant annually

- (2) The following powers are delegated to the Director of Rural Development (Training)
  - (i) to approve the budget for the training institutions (RETCs) within the Rs. 5.0 lakhs of the revolving fund, which is the amount being sanctioned by the Government of India as recurring grant.
  - (ii) To approve proposals within the amount of grants-in-aid (recurring and non-recurring) sanctioned by the Government of India from time to time.
  - (iii) To approve proposals for improvements for RETCs within the accumulated balances including interest.

## 3. TRAINING

- (3) Powers are delegated to the Principals, Rural ExtensionTraining Centres to incur expenditure for the proposals approved by Director of Rural Development (Training).
- (4) It is to be ensured that all Government procedures, the Tamil Nadu Transparency in Tenders Act/Rules 1998 and other orders in force in regard to the powers delegated are followed before sanction of expenditure.
- (5) Monthly/ Quarterly periodicals may be prescribed so as to enable the Principals, Rural Extension Training Centres to send the returns to Director of Rural development. (Training ) for the expenditure incurred.
- 3. This order issues with the concurrence of Finance Department Vide its U.O.No. 310/SS(LK)/03, dated 7.10.2003.
