

**2.77 602 Technical and 81 Non-Technical temporary posts - Further continuance from 01.07.2001 to 30.6.2003**

**ORDER**

A separate Engineering Wing for Rural Development Department was created and orders were issued for the sanction of both technical and non-technical posts totaling to 683 posts for a period of 3 years from 27.12.1998 in the G.O. first read above. Sanction was subsequently accorded for the continuance of the 602 technical posts for the period from 27.12.1999 to 30.6.2001 and 81 non-technical posts from 01.07.2000 to 30.06.2001 in the G.O. second read above.

2. The Director of Rural Development after reviewing the performance of technical wing has reported in his letters third read above, that at present various types of works are being executed by Rural Development Department and the budget allocation for 1997-98 is double the allocation of the previous year and for 2000-2001 it has tripled. He has confirmed that the posts mentioned in the Annexure to the G.O. second read above have been surrendered and pay and allowances are not claimed. For sustaining the speed of work and to ensure quality and to achieve the target in the coming years the Director of Rural Development has required for the further Continuance 602 Technical Posts and of 81 non-technical posts for a period of 3 years from 01.07.2001 to 30.06.2004.

3. The Government accept the proposal of the Director of Rural Development and direct that the 602 technical posts and 81 non-technical posts which are shown in Annexure to this order be continued for further period of years from 01.07.2001 to 30.6.2003.

4. The incumbents of the posts are eligible to draw the Pay and D.A. and other allowances as admissible under the orders in force.

5. The expenditure relating to the posts mentioned in the Annexure-I shall be debited to "2505. Rural Employment – 01 National Programmes – 702. Jawahar Gram Samridhi Yojana – Schemes in the tenth Five Year Plan-II State Plan JA Jawahar Gram Samridhi Yojana – 01 Salaries. DPC No.2505-01-702-JA-0106".

6.The Collectors are requested to communicate this order to the concerned officers under their control. (including Sub-Treasury Officers)
