1.29 Temporary post of Assistant Engineer in the Rural Development Department - Amendment to Adhoc Rules

ORDER

The following Notifications will be published in the TamilNadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of TamilNadu hereby makes the following amendments to the adhoc rules for the temporary post of Assistant Engineer in the Rural Development Department published with the Rural Development Department Notification No.SRO B-63/2000 at page 75-77 of Part III Section 1(b) of the TamilNadu Government Gazette dated the 24th May 2000.

2. The Amendment hereby made shall be deemed to have come into force on the 25th May, 1998.

AMENDMENTS

In the said Rules:-

(1) In rule 3-

(a) for sub rule (b) the following sub-rule shall be substituted, namely:-

"(b) recruitment by transfer from among the holders of the post of Overseer in the Rural Development Department."

(2) after sub-rule (c), the following proviso shall be added namely:-

"Provided that the cadre strength shall be maintained between Assistant Engineers (of the TamilNadu Panchayat Development Service) and Junior Engineers (of the TamilNadu Panchayat Development Engineering Sub-ordinate Service) in the ratio of 3:1 at any time."

(3) In rule 5 -

(a) in sub-rule (a) for the expression "thirty five years" the expression "thirty years" shall be substituted

(b) for sub-rule (b) the following sub-rule shall be substituted, namely:-

(b) Other qualifications:- No person shall be eligible for appointment to the post by the method specified in column(1) of the Table below, unless he possesses the qualification specified in the corresponding entries in column (2) thereof:

THE TABLE

Method of Appointment (1)	Qualification (2)
a) Direct recruitment	<p>Must possess a B.E. degree in Civil Engineering; or Must have passed Sections A and B of the Institution of Engineers(India) in Civil Engineering Branch, and he should furnish evidence of having undergone practical training in surveying for a period of not less than one year.</p> <p>Provided that other things being equal preference shall be given for appointment to a person who has undergone one year Apprenticeship under the Government of India Scheme or the State Government Apprenticeship Scheme."</p> <p>Provided further that in respect of the selection made by direct recruitment to the post of Assistant Engineer on the 26th September 1997 the qualification shall be as follows.</p> <p>A B.E. Degree in Civil Engineering of any University or Institution recognized by the University Grants Commission for the purpose of its grants."</p>
(b) Recruitment by transfer	<p>Must possess a B.E. degree in Civil Engineering or Must have passed Sections A and B of the Institution of Engineers (India) in Civil Engineering Branch and he should furnish evidence of having undergone practical training in Surveying for a period of not less than one year; and</p> <p>2. Must have rendered service as Overseer or Junior Draughting Officer, as the case may be, for a period of not less than five years;</p>

(4) After Rule 5, the following rule shall be inserted, namely: -

"5-A.The approved list of candidates for appointment by recruitment by transfer shall be prepared with reference to the seniority of the candidates, based on the date of passing the B.E. degree in Civil Engineering or a pass in Sections A and B Examinations(AMIE) conducted by the Institution of Engineers(India)"

(5) To Rule 7(ii) the following proviso shall be added namely: -

"Provided that this rule shall take effect on the 25th May 1998"

(6) In Rule 8, in sub-rule (a) for the expression "Every person appointed to the category of Assistant Engineer by direct recruitment shall pass the following tests within the period of probation", the expression "Every person appointed to the post of Assistant Engineer by recruitment by transfer shall pass the following tests within a period of two years" shall be substituted.

(7) In Rule 9, for the expression "Rs.6500-200-10,500" the expression "Rs.2000-60-2300-75-3200-100-3500 on the 26th September 1997, which has been revised in the Sixth Pay Commission as Rs.6500-200-11,100" shall be substituted.
