ORDER

In the G.O. fourth read above, Government have constituted the Tamil Nadu Panchayat Development Subordinate service covering the posts of Block Development Officer, Deputy Block Development Officers and Extension Officers. Government, therefore issue the rules for the service. The appended Notification will be published in the Tamil Nadu Government Gazette.

2. Amendments to the Tamil Nadu Ministerial Service Rules for the deletion of provision relating to the posts of Superintendents, Panchayat Development Accountant and Manager will be issued separately from Personnel and Administrative Reforms Department.

APPENDIX

NOTIFICATION I

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, Governor of Tamil Nadu hereby issues the following Special Rules for the Tamil Nadu Panchayat Development Subordinate Service, which will form Section 47 in Volume-III of the Tamil Nadu Service Manual, 1970.

2. The Special Rules hereby made shall be deemed to have come into force on the 1st June 1970.

Section 47 :- THE TAMIL NADU PANCHAYAT DEVELOPMENT SUBORDINATE SERVICE.

Constitution :- The service shall consist of the following categories of officers, namely:-

Category 1. Block Development Officer.

Category 2. Deputy Block Development Officer (Executive);

Deputy Block Development Officer (Administration); and

Deputy Block Development Officer (Accounts).

Category 3. Extension Officer (Panchayats);

Extension Officer (Social Education and Public Relation);

Extension Officer (Administration); and

Extension Officer (Accounts).

Explanation: "Block Development Officer" shall mean and include Panchayat Sheristadar

and the Block Development Officer (Accounts) of the Directorate of Rural

Development.

2(a) Appointment: Appointment to the posts specified in column(1) of the Table below shall be

made by the methods specified in the corresponding entries in column (2)

thereof.

- (b) Promotions shall be made on grounds of merit and ability, seniority being considered only where merit and ability are approximately equal.
- (c) Qualification: No person shall be eligible for the posts specified in column (1) of the Table below by the methods specified in the corresponding entries in column (2). Unless he possess the qualifications specified in the corresponding entries in column (3) thereof.

- 4. Appointing authority: (a) The Director of Rural Development shall be appointing authority for all the posts in the Madras District Unit and for the post of Block Development Officer.
 - (b) The Collector of the revenue district concerned shall be the appointing authority in respect of all other posts in the respective district units.
- $\underline{5.\ Probation}$ (a) Every person appointed to category 3 by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years.
 - (b) The Director of Rural Development shall be the authority competent to declare the satisfactory completion of probation in respect of all the posts in the Madras District Unit and the post of Block Development Officer.
 - (c) The Collector of the revenue district concerned shall be the authority competent to declare the 'satisfactory completion' of probation in respect of all the posts other than the post of Block Development Officer in the district units.
- <u>6. Unit for Appointment, Reversion, discharge, etc.</u>—(a) For the purpose of appointment, reversion or discharge for want of vacancy re-appointment of probationers and approved probationers and appointment as full member as Block Development Officer, the State shall be the unit.
 - (b) For the purpose of appointment, reversion or discharge for want for vacancy and reappointment of probationers and approved probationers and appointment as full member to the posts other than the post of Block Development Officer, each revenue district shall be the unit:

Provided that the Deputy Block Development Officer (Administration), Deputy Block Development Officer (Accounts) and Extension Officer (Accounts) in the Directorate of Rural Development and the Office of the Chief Radio Officer and Regional Radio Officer, Madras of the Tamil Nadu Local Administration, Radio and Television Maintenance Organisation shall constitute the Madras District Unit.

1. SERVICE RULES

- 7. Postings and Transfers.—(a) Postings and transfers within the district shall be made by the District Collector and from one district to another district by the Director of Rural Development, madras
 - (b) In case of transfer by mutual consent or at request, from one district to another district, the person shall take his rank last in the list of probationers or approved probationers or full members, as the case may be, in that category.
- 8. Training: The Extension Officer (Accounts) of the Madras District Unit shall undergo training for a period of three years as may be prescribed during which he shall workas Extension Officer (Panchayat), Extension Officer (Administration) and Extension Officer (Social Education and Public Relation) for a period of one year each.
- 9. Preparation of Panel: A list of approved candidates shall be prepared taking into consideration the claims of all persons who have become qualified and eligible by the first March of the year in which the list is prepared and shall be published in the office notice board of the appointing quthority on the same or the every next day of its approval by the appointing authority.

NOTIFICATION II

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu General Subordinates, Service (Section 13 in Volume III of the Tamil Nadu Services Manual 1970).

2. The amendments hereby made shall be deemed to come into force on the 1st June 1979.

AMENDMENTS

In the said Special Rules,

- (1) In part I, the expression "Class LVIII" and the entry thereunder shall be omitted.
- (2) In part II, the expression "Class LVIII Education Extension Officers" and the rules thereunder shall be omitted.

NOTIFICATION III

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules contained in Volume III of the Tamil Nadu Services Manual, 1970.

2. The amendment hereby made shall be deemed to have come into force on the 1st June 1979.

AMENDMENT

In the said Special Rules, the expression "Section 24 of the Tamil Nadu Panchayat Development Subordinate Service" and the Rules thereunder shall be omitted.
