1.34 Tamil Nadu Gramasevaks Service - Posts of RWO Grade I and Grade II brought under Tamil Nadu Ministerial Service Rules - Amendment to Special Rules

ORDER

The Government have decided that the posts of Rural Welfare Officer, Grade I and Rural Welfare Officer, Grade II shall be brought under the Tamil Nadu Ministerial Service Rules, with effect from 1.6.1979. In view of this, the provisions relating to the Rural Welfare Officer Grade I and Grade II in the Tamil Nadu Gramasevak Service Rules Will have to be deleted.

The following notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Gramasevak Service.

2. The amendments hereby made shall be deemed to have come into force on the 1st June 1979.

AMENDMENTS

In the said Special Rules, -

- 1) in Rule 1, -
 - a) in Class I, the expression, "Category-2 Gramasevaks Grade I" shall be omitted;
 - b) in class II, the expression "Category-2 Gramasevaks Grade II" shall be omitted;
- 2) in the Table under Rule 2, -
 - a) in Class I the expression "Category-2 Gramasevaks Grade I in column (1) and the entry relating thereto in column(2) shall be omitted;
 - b) in Class II, the expression "Category-2 Gramasevaks Grade II in column(1) and the entry relating thereto in Col.(2) shall be omitted.
- 3) in the Table under rule 5, -
 - a) in Class I, the expression "Category-2 Gramasevaks Grade I" in column (1) and the entries relating thereto in columns (2) and (3) shall be omitted.
 - b) in Class II, the expression "Category-2 Gramasevaks Grade II" in column(1) and the entries relating thereto in columns (2) and (3) shall be omitted:
 - c) Explanations I and II shall be omitted;

- 4) in Rule 6, -
 - a) Sub-rule(2) shall be omitted;
 - b) in the first proviso to sub-rule(4), for the expression "Grade 1 and 2 in Class II" the expression "Category 1 in Class II" be substituted;
 - c) the second proviso shall be omitted;
- 5) In Rule 7, - the first proviso shall be omitted;
- 6) Rule 8 shall be omitted;
- 7) In Rule 9, sub-rules(a) and (b) shall be omitted;
- 8) In Rule 10, the expression "to category-2 in Class II and shall be omitted.
- 9) In Rule 10-A shall be omitted;
- 10) In Rule 12, the expression "and Gramasevaks Grade II" shall be omitted;
