

**3.1 State Institute of Rural Development - Sanction of eleven posts - Lecturers, Financial Advisor, Librarian etc.,**

**ORDER**

The State Institute of Rural Development, Madras is being developed as an apex institution for training the Rural Development functionaries and research in Rural Development, under the Centrally Sponsored Scheme. The Government in their order first read above have issued orders for the registration of the State Institute of Rural Development as society under the Tamil Nadu Societies Registration Act 1975 and the State Institute of Rural Development has since been registered as Society on 2.5.90. The National Institute of Rural Development has been pressing the State for strengthening the faculties of the State Institute of Rural Development, with a view to improve the quality of training. The Principal, State Institute of Rural Development in his letter 2nd read above has submitted proposals to Government for the sanction of certain additional staff for strengthening the State Institute of Rural Development. The expenditure on the staff of the State Institute of Rural Development is being shared by the Central and State Governments on 50:50 basis.

2. After careful consideration, the Government have decided to accord sanction for the creation of the following posts in the State Institute of Rural Development, Madras.

3. The following three posts of Lecturers which were already sanctioned but not filled up should be surrendered.

### 3. TRAINING

- (i) Lecturer in Rural Credit and banking.
- (ii) Lecturer in Project Management
- (iii) Lecturer in Area Planning.

One more post of Lecturer in the cadre of Divisional Development Officer in the State Institute of Rural Development should also be surrendered.

4. The Principal, State Institute of Rural Development is also permitted to employ four gardeners and two sweepers on part-time daily wage basis.

5. The Staff sanctioned in para 2 above are eligible for the pay, Dearness Allowance and other allowances as admissible under the orders in force.

6. The expenditure should be met from the Grant-in-aid to the State Institute of Rural Development under "2515 other Rural Development programmes-003 Training-I Non-Plan-AA State Institute of Rural Development-09 Grants in aid "D.P.C.No.2515-00-003 AA 0900.

7. The Government also approve the proposal for setting up the Library of the State Institute of Rural Development in the new building at a cost not exceeding Rs.10 Lakhs (Rupees Ten Lakhs only). The expenditure on this account should be met from the interest earnings of District Rural Development Agencies funds on a shared basis.

8. This orders issues with the concurrence of Finance Department vide its U.O.No.94075/RD/90/dated 20.8.90.
