2. In the G.O. fourth cited, amendment has been issued to rule 4 (a) of the Special Rules of the Tamil Nadu Panchayat Development Engineering Subordinate Service Rules. According to the amended Special Rule of the Tamil Nadu Panchayat Development Engineering Sub-ordinate Service Rules, Rule 12(d) of the General Rules is not applicable for appointment by direct recruitment for the posts of Overseers, Junior Draughting Officers and Road Inspectors Grade II in the Rural Development and Panchayat Raj Department and persons who have not completed 35 years of age as on 1<sup>st</sup> July of the year in which the appointment is made for the posts of Overseers, Junior Draughting Officers and Road Inspectors Grade II in Rural Development and Panchayat Raj Department in addition to relaxation of 5 years of age granted in G.O.(Ms) No.98, Personnel and Administrative Reforms Department, dated 17.7.2006 are eligible for appointment, subject to fulfillment of other qualifications prescribed for the posts in the said categories. According to the existing Special rule of the Tamil Nadu Panchayat Development Engineering Subordinate Services, those who have completed 40 years of age (35+5) are not eligible for appointment by direct recruitment to the said posts, in the said categories. In pursuance to the above amendment, detailed instructions on this issue have been issued and you were requested to display the said (amended rule) Gazette Notification on the notice boards of the Directorate of Rural Development & Panchayat Raj, Collectorates and in the District Employment Exchanges in the reference 5<sup>th</sup> cited.

3. I am to reiterate the earlier instructions issued in the reference 5<sup>th</sup> cited and request you to follow the amended rule 4(a) of the Special Rules for the Tamil Nadu Panchayat Development Engineering Subordinate Service Rules, according to which those who have completed 40 years of age (35+5) are not eligible (Rule 12(d) of the General Rules is not applicable in the instant case) for appointment by direct recruitment to the posts of Overseers/Junior Draughting Officers/Road

Inspectors Grade II scrupulously. In the event of any violation in following the above age qualification, that will be viewed very seriously in Government.
