ORDER:

In the Government Order second read above, the Government have sanctioned a sum of Rs.166.50 crores (Rupees one hundred and Sixty six crores and fifty lakhs only) to the Village Panchayats as first instalment of General Basic Grant recommended by the 13th Finance Commission for the year 2011-12 pending receipt of grants from Government of India.

2. Since, the Government of India release is higher, the Principal Secretary, Finance Department has requested to furnish proposals along with draft order for the release of eligible balance grant of Rs.17.36 crores to the Rural Local Bodies and Urban Local Bodies in his letter third read above. In this connection, the Commissioner of Rural Development and Panchayat Raj Department in his letter fourth read above has requested the Government to sanction the eligible balance general basic grant of Rs.9.81crores towards the first instalment for the year 2011-12 pertaining to Rural Local Bodies.

3. The Government have examined the proposal of the Commissioner of Rural Development and Panchayat Raj carefully and decided to accept the same. Accordingly, the Government sanction the release of eligible balance general basic grant of Rs.9,81,00,000/- (Rupees Nine crores and eighty one lakhs only) to Village Panchayats towards first instalment release for the year 2011-12.

4. The expenditure sanctioned in para 3 above shall be debited under following Head of Account:

“3604-00-Compensation and Assignments to Local Bodies and Panchayat Raj Institutions – 197. Assistance to Block Panchayats/Intermediate level Panchayats Schemes in the Eleventh Five Year Plan – II State Plan – JE – Grants to Village Panchayats as per the recommendations of 13th Finance Commission – 09. Grants-in-aid – 01. Grants for Current Expenditure.” (DPC 3604-00-197-JE-0913)

5. The Commissioner of Rural Development and Panchayat Raj Department is authorized to draw and disburse the amount sanctioned in para 3 above to all the Village Panchayats and the grant shall be utilized in conformity with the instructions issued in the Government Order first read above.
