ORDER:

In the letter first read above the Government have issued policy directions to the Tamil Nadu Electricity Regulatory Commission that free supply of electricity shall be extended to Agricultural Consumers (except Self Financing Schemes) and hut consumers from 1.4.2004.

2. In the letter 2nd read above, Government conveyed their concurrence under Section 108 (1) of Electricity Act 2003 to continue the policy direction by providing the grants / subsidy to the Tamil Nadu Electricity Board, in advance as per Section 65 of the Electricity Act, 2003.

3. In the reference third read above orders have been issued sanctioning a sum of Rs.7.50 Crores as advance Grants - in - Aid to compensate the shortfall in revenue due to the free supply of Electricity to Hut consumers for the period from 1.4.2010 to 30.9.2010 to Hut consumers to ensure continuance of free supply to Hut consumers for the period beyond 31.3.2010. In the reference fifth cited, orders have been issued sanctioning a sum of Rs.11.68 Crores (Rupees Eleven Crores and Sixty Eight Lakhs Only) as advance Grant - in - Aid

to compensate the shortfall in revenue due to the free supply of Electricity to the Hut consumers for the period from 1.10.2010 to 31.3.2011 after adjusting the additional subsidy of Rs.1.26 Crores to the year 2008-2009 and with the payment of balance subsidy of Rs.1.46 Crores for the period from 1.4.2010 to 30.9.2010.

4. The Chairman and Managing Director, TANGEDCO has now requested the Government to sanction and release a sum of Rs.8.96 Crores as advance Grants - in - Aid to compensate the shortfall in revenue, due to the free supply of electricity to the Hut consumers for the period from 1.4.2011 to 30.9.2011, to the TANGEDCO, pending clearance by the Tamil Nadu Electricity Regulatory Commission.

5. The Government have examined the above proposal carefully and accord sanction for a sum of Rs.8.96 Crores (Rupees Eight Crores and Ninety Six Lakhs Only) as advance Grants - in - Aid to compensate the shortfall in revenue due to the free supply of Electricity to the Hut consumers for the period from 1.4.2011 to 30.9.2011 to the TANGEDCO, pending clearance by the Tamil Nadu Electricity Regulatory Commission.

6. The amount sanctioned in para 5 above shall be debited to the following Head of Account:-

“ 2515 – 00 – Other Rural Development Programmes – 102. Community Development I. Non – Plan – AD. Payment to Tamil Nadu Electricity Board on behalf of Rural hut dwellers – 09. Grants in Aid – 03 Grants for Specific Schemes”.

7. The Director of Rural Development is authorised to draw and disburse the amount sanctioned in para 5 above. He is requested to present the bill in the Pay and Accounts Officer (South), Chennai – 35 and to ensure that the sanctioned amount shall be paid to the TANGEDCO on 31.3.2011.
