**ORDER:**

The Commissioner of Rural Development and Panchayat Raj has stated that a sum of Rs.94,28,000/- has been provided as Maternity grant and a sum of Rs.29,000/- has been provided as Allopathy grant in the Demand NO.42, of 2008-2009 in the following head of Accounts:-

BR Maintenance Grant for Maternity Centres of Local / Bodies 01 Grants for current Expenditure. Rs.94,28,000/- 2210 Medical & Public Health 03.Rural Health Service – Allopathy 110. Hospitals and Dispensaries 1 Non Plan A1 Grants for Dispensaries of Panchayat Unions 09 Grants in Aid Rs. 29,000/-
